# REGULAR SESSION-November 17, 1884.

The Common Council of the City of Indianapolis, met in the Council Chamber, Monday evening, November 17th, A. D. 1884, at seven o'clock, in regular session.

S. O. 146, 1884—An ordinance to provide for grading and graveling Orange street and sidewalks, from Spruce street to Re'd street.

INTRODUCTION OF MISCELLANEOUS BUSINESS.

Councilman McClelland presented the following petition; which was referred to the Committee on Streets and Alleys:

To the Mayor, Common Council and Board of Aldermen:

Gentlemen:—The undersigned respectfully petition your honorable bodies for the vacation of two alleys, fully described herein according to the plat here e annexed, to-wit: The alley (12 feet wide) running from Railroad street to Peru street or avenue, between lots one hundred and thirty (130) and one hundred and thirty-one (131), in out-lot forty five (45), Indianapolis; also, the alley (12 feet wide) running from said Roilroad street to Peru street or avenue, between lots one hundred and twenty-nine (129) and one hundred and thirty (130), in said out-lot forty-five (451, Indianapolis, and between North and Walnut streets And your petitioners will ever pray, &c. W. B. Allen & Co.

Councilman Rees presented the following petition; which was approved:

To the Mayor, Common Council, and Board of Aldermen:

Gentlemen:—The undersigned respectfully make application for license to conduct a Museum and Theatre in the building situate on the corner of Washington and Tennessee streets, commonly known as the Park Theatre.

Councilman Smither offered the following motion; which was adopted:

That the Mayor give Mr. Hays an order for the possession of the Scales on West Market, the same having passed both Council and Board of Aldermen.

Councilman Spahr offered the following motion; which was adopted:

That the owners of the real estate abutting on Bellefontaine and Greenwood streets, are hereby permitted and authorized to grade and gravel said streets and the alleys corresponding, between Bruce street and Eleventh street (formerly Reagan street), at their own expense, according to grade which the City Civil Engineer shall furnish.

Councilman Smither was excused for the remainder of this session.

Councilman Spahr offered the following motion; which was referred to the Judiciary Committee and City Attorney:

That the City Clerk be, and he is hereby, authorized and directed to satisfy the lien held by the city on Lot number six (6), in Fiscus's subdivision of the east half of Lot 21, in Johnson's heirs' addition to the City of Indianapolis, Marion County, State of Indiana, said lien being for the opening of Rohampton street—said lot being now owned by Mrs. Alice Echols, widow.

Councilman Thalman presented the following petition; which was referred to the Judiciary Committee:

To His Honor, the Mayor, Members of the Common Council and Board of Aldermen:

Gentlemen:—Your petitioner would respectfully represent that at the public tax sale held by the city on February 11th, 1884, he purchased from the City Treasurer tax sale certificates on Lots 413, 414 and 415, in Fletcher et al's. subdivision of Outlot 98, for which he paid the sum of \$41.94. Of this amount there was an overcharge of \$12.20, by an error in carrying the amount of the tax on the lots for 1882, as that had been paid, and the credit overlooked when the tax was carried. The full amount of the legal taxes have been paid to the petitioner by the owner of the property, leaving the overcharged taxes paid by me to the city, still unpaid and

due me. Owing to the above statement of facts in the overcharge of taxes, and still unpaid to me, your petitioner would respectfully ask and demand that the sum of \$12.20, overcharged taxes, be refunded me, with interest from February 11, 1884; and as in duty bound, your petitioner will ever pray.

The first lamp-post north of Kentucky avenue, on Mississippi street, east side, be dis-mantled, and a bracket lamp be erected on the corner of Chesapeake street and the alley west of Illinois street, on the corner of the said street and alley.

Councilman Trusler offered the following motion; which was adopted:

That the monthly reports of the Superintendent of the City Hospital and Branch, Superintendent of the City Dispensary, and the Mortality reports of the Board of Heal h, be placed on file in the office of the City Clerk, and not printed in the Proceedings.

Councilman Trusler offered the following motion, which was referred to the Board of Public Improvements:

That the Street Commissioner be instructed to repair the gutters on Spruce street, below Orange, so that the water may be discharged into Pleasant Run without injury to the banks, or bridge across said Run.

On motion, the Common Council then adjourned.
