We do not feel that such a precedent should be set.

Councilman Spahr presented the following petition; which was referred to the Committee on Accounts and Claims:

To the Mayor, Common Council and Board of Aldermen :

Gentlemen:—I ask the city to pay me \$75.00 for my buildings connected with the West Market Scales, and \$15.00 paid by me for repairs on Scales—the city having leased the same to another party. I have explained the facts connected with this matter to various members of your honorable bodies.




