The Board of Health submitted the Mortality report for two weeks ending November 30th, 1884, showing sixty-nine deaths; which was read and received.

The Board of City Commissioners submitted the following report; which was non-concurred in:

Report of the City Commissioners in the matter of straightening Massachusetts avenue.

To the Mayor, Common Council and Board of A'dermen:

Gentlemen:—The undersigned, members of the Board of City Commissioners of the City of Indianapolis, duly appointed, sworn and qualified, and acting under and in pursuance of the Act of the General Assembly of the State of Indiana in relation to the laying out, opening, widening, altering and vacation of streets, etc., approved March 17tb, 1875, and acts amendatory thereto, do report:

- 1st. That in pursuance of a notice of the City Clerk, herewith filed as a part hereof, marked exhibit "A," they met in the City Clerk's office, on Friday, the 10th day of October, 1884, at 10 o'clock, A. M.
- 2d. They did, at that time and place, enter upon the consideration of widening and straightening Massachusetts avenue, and condemning a certain triangular strip of ground taken off of Lots 73 and 75, in Butler's second addition to the City of Indianapolis, more clearly shown by the petition and plat filed herewith, and marked exhibit "B;" and they did, on said 10th day of October, meet on the ground and examine the property proposed to be taken for such street, also the surrounding property, with a view of ascertaining what property would be benefited and what property damaged thereby; and they did then file with the City Clerk their report giving a description of the property, with the owner's name, which report instructed the City Clerk to require the Superintendent of Police to notify the interested parties to meet the City Commissioners on the 8th day of December, 1884, at 10 o'clock A.M., in Room 6 of the City Clerk's office, to hear evidence and further consider said petition. Said report is filed herewith as a part here, f, and marked exhibit "C."
- 3d. They did meet on said 8th day of December, 1883, (a full board being present), and entered upon the further consideration of the case. J. W. Ray being present, entered a protest against the powers of the Commissioners to appropriate any portion of his private property for the public use. Whereupon the City Attorney was counseled, who gave it as his opinion that the City Commissioners have jurisdiction over all such cases, and that the proceedings in the case were regular and according to law.
  - 4th. We do now, on the 8th day of December, report that there is no damage

to any property on account of straightening said street, except where a portion of said property is taken therefor.

5th. Said straightening commences in the south line of Lot 73 (above described), at its intersection of the north line of Massachusetts avenue, a distance of 59.7 feet west from the southeast corner of Lot 75; thence a northeasterly direction, with the north line of Massachusetts avenue extended a distance of 78.9 fect to the east line of Lot 75, intersecting Alvord street at a point 51.8 feet north of the southeast corner of said Lot 75, cutting off a triangle off of the southeast corners of Lots 73 and 75—containing 1,546 square feet, (more or less.)

6th. No private property is materially benefited by said change in the street, the City of Indianapolis being the only party benefited.

7th. The damage to be paid by the city is \$500.00, and we so assess it.

Sth. John W. Ray is the owner of the ground appropriated and is entitled to the award for the damages thereto, and in consideration of which will convey to the City of Indianapolis a deed to the above described ground.

9th. The cost in the case is \$48.00.

We therefore recommend that the prayer of the petition be granted.

Councilman Mack, in behalf of the same Committee, submitted the following report; which, on motion by Councilman Thalman, was received:

To the Mayor and Common Council:

Gentlemen:—Your Committee on Public Property would herewith report that H. English, the former tenant of Garfield Park, has finally left the same, according to order of the Court, and that Fred Fells, appointed by the committee last spring, has taken possession thereof.

Your committee has made a thorough investigation of the Park and found the same in a very bad condition. The fences are partly torn and blown down, part of the sheds and amphitheater are also torn down and the lumber carried away.

The house on the place is also in a bad condition. The sills of the rear part of the house are partly broken and the cellar is filled with water. The roof of the rear part also needs repairing. We would recommend that all buildings partly torn down would be torn down entirely, and the lumber of the same stored away for future use. Also that the tences around the Park be ent down to about five feet in height and put in good order. Also that a flood-gate be put over Pleasant Run at the north end of Park. Also that a brick foundation be put under rear part of house and the roof of same be repaired. Mr. Fells, the occupant of the place, who has had experience in this kind of work, has made an offer to the committee to do all this work at \$1.50 per day and to furnish an assistant for some less.

Your committee estimates the cost of these improvements, material and labor, at about \$600, and would recommend, in ease the city should not have the money to spare at the present time, to sell a number of large trees in the Park, some of them being in swampy parts of the Park and some getting dry tops and are therefore of no benefit to the Park whatever, but would bring a good price for saw logs, etc., which would pay for the greater part of the improvements.

Gentlemen:—I presume that you all know of the accident that happened that Thanksgiving Day at noon, between tweive and one o'clock. George and Roman Oehler, Jr., had been sent on an errand from No. 183 south side of west Washington street, one quarter of a square east of the railroad track. The railroad track is the only crossing on Missouri and Washington streets, and as they were very near across, Roman, aged six years, stumbled and fell, and Whitehead's delivery wagon ran over him and killed him instantly. If we would have had safety gates and foot crossings, the boy's life would have been saved. What we ask of this Council, is to give us safety gates and foot crossings, where hundreds of women and children have to cross on market days at this point.

To the Mayor and Common Council:

Gentlemen:—"Your Committee on Contracts, to whom was referred the resolution and bond concerning the city bill posting under John R. Fohl's proposition, beg leave to report, that they have considered the matter, and would recommend that

the resolution introduced September 15th, be amended as follows: Add a'ter the words "approval of said bond," the following: "Provided, that this contract with said Fohl shall not be construed to include any other bridges, market houses or other public grounds or property than those now and which have heretofore been used for such bill posing, a complete schedule of which places shall be reduced to writing and agreed on between said Fohl and the Street Commissioner."

Indianapolis, Dec. 8, 1884.

To the Honorable, the Mayor, Common Council and Members of the Board of Aldermen:

Gentlemen:—The undersigned petitioner would respectfully represent to your honorable bodies that she is the owner of the property on the northeast corner of Benton and Meek streets, and that she owns one hundred and thirty feet (130) along the east side of Benton street; that about nine years (9) ago she had the gutter along the aforesaid (130) feet bowldered according to stakes set by the City Civil Engineer, "at her own expense."

Your petitioner further represents that the gutter along the aforesaid (130) feet was taken up and a new gutter laid by the contractors, "Richter and Twiname," against the plain provision of the ordinance passed for the improvement of said Benton street, which ordinance reads:

"An ordinance to provide for bowldering the gutters, paving with brick, and curbing with stone the sidewalks of Benton street, from Washington street to Bates streets, where not already done."

Having at one time, under stakes set by the City Engineer, as aforesaid, bowldered the gutter along the 130 feet on Benton street at her own expense, your petitioner would most respectfully ask from your honorable bodies that said contractors, "Richter and Twiname," be restrained from collecting the cost of bowldering said 130 feet along her property on said Benton street, she having at one time bowldered said gutter at her own expense, and the ordinance passed by your honorable bodies 19th of May, 1884, in Council, and May 26th, 1884, in Board of Aldermen, positively forbid said contractors to improve my portion of said Benton street that had been already improved; therefore, your petitioner respectfully prays that such justice may be done her as in your judgment seems best.

To the Mayor and Common Council of the City of Indianapolis:
