The undrrsigned, residents of the city of Indianapolis, respectfully show that the Union Starch Factory, located on East New York street, near the old corporation line, as operated and carried on, is so offensive to the senses, and such an obstuction to the free use of property, as to essentially interfere with the comfortable enjoyment of life and property, and constitutes a nuisance to the residents of a large district in the neighborhood and for a great distance beyond in various directions; and they ask that the same be abated and removed by order of the Council.

Which was adopted, and Messrs. Harrison, Brown, Newman, Wiles and Cottrell appointed as said committee.

Mr. Heckman offered the following motions:

Moved, That Mr. P. L. Renard be and he is hereby permitted to boulder the sidewalk in front of his property on Buchanan street, between Virginia Avenue and Water street, and that the Civil Engineer be and he is hereby directed to set the proper grade stakes.

That Mr. John Fike be and he is hereby permitted to boulder the sidewalk in front of his property on Virginia avenue, between Stevens and McCarty streets, and that the Civil Engineer be and he is hereby directed to set the proper grade stakes.

Which were adopted.

Mr. Kahn offered the following motion:

Moved, That the Street Commissioner report what disposition was made of the West Market House, and if the same is not disposed of, that the City Clerk advertise the same for sale.

Which was laid on the table.

Mr. Kennington introduced Special Appropriation Ordinance No. 72, 1870, entitled:

An Ordinance making an appropriation toward purchasing the National Road Bridge over White River for the purpose of making the same a bridge free from toll.

Which was read the first time, and referred to the Committee on Bridges, together with Councilman Thalman.

Mr. Marsee offered the following motion:

Moved, That the contract for bouldering the gutter, and curbing the outside edge of the sidewalk on the west side of New Jersey street, between South and Merrill streets, be declared forfeited, and that the Street Commissioner be directed to notify the contractor to remove the boulders from said street within ten days from this date.

Which was adopted.

Mr. Reagan offered the following petition and motion:

Indianapolis, Dec. 19, 1870.

To the Mayor and Common Council of the City of Indianapolis:

I hereby solicit the laying of the flagging to be laid at the corner of Illinois and Georgia streets, in the city of Indianapolis, upon the following terms, to-wit: Thirty-eight (38) cents per foot square, the stone to be not less than four (4) nor more than six (6) inches in thickness.

Moved, That a committee of three be appointed, who, with the City Attorney, shall confer with Messrs. Lawyer & Hall and their counsel, in reference to a compromise of the case of Messrs. Lawyer & Hall against the city, and report the result of such conference to the Common Council.

Which was adopted, and the following committee appointed: Messrs. Wiles, Brown and Woodburn.

Dr. Woodburn presented the following petition:

Indianapolis, Dec. 15, 1870.

To the Mayor and Common Council of the City of Indianapolis:

Gentlemen: For the year 1869 I was assessed with, \$8,475.00 personal property by the City Assessor, who made out the tax list of 1869 from the one of 1868, without my knowledge or consent. As I did not have that amount of personal property for taxation, and as I paid the tax of \$99.83 on the same, under protest, I respectfully ask that all but the tax on \$1,815.00, with penalty, interest, &c., be refunded to me, this being the correct amount of personal property I owned for the year 1869 liable for taxation, making the amount due to me on account of erroneous taxation \$78.55, and I will ever pray, &c.

GENTLEMEN: The undersigned. Moved, That the Street Commissioner be and he is hereby instructed to clean the street crossings on North Pennsylvania street, where they need it.

Which was adopted.

Mr. Thalman offered the following motion:

Moved, That the Street Commissioner place two iron foot bridges at the crossing of Washington and Meridian streets.

Which was referred to the Committee on Bridges.

Dr. Woodburn introduced Special Ordinance No. 225, 1870, entitled:

An Ordinance to grade and gravel the south sidewalk on Tinker street, between Illinois and Tennessee streets.

Which was read the first time.

Mr. Harrison offered the following motion:

Moved, That the Council now proceed to the election of a City Commissioner to fill the vacancy occasioned by the resignation of William Braden.

Which was adopted.

William S. Hubbard was put in nomination by Dr. Woodburn and unanimously elected.

Dr. Woodburn presented the bill for keeping prisoners at the Station House for the month of November, 1870.

The Finance Committee, to whom was referred the several petitions of Mary H. Alvord and E. T. Miller, beg leave to report:

The petitioners severally complain of erroneous assessments for taxation in the city for the year 1868, and from the length of time that has intervened since the assessment, they think it would be setting an impolitic precedent to disturb the assessments complained of, and they, therefore, report against the claims of said petitioners, and beg to be discharged from the further consideration of said petitions.

By consent, Dr. Woodburn introduced Special Appropriation Ordinance No. 73, 1870, entitled:

An Ordinance appropriating money for the payment of sundry claims against the city of Indianapolis.

Which was read the first time.

Dr. Woodburn presented the following agreement:

This agreement, made this 19th day of December, 1870, between the Trustees of the "Bobbs Free Dispensary," and the City Council of Indianapolis, through their Committee on Benevolent Institutions and Hospitals,

Witnesses, That the party of the first part agree to furnish Medical and Surgical service to the city poor, including attendance upon the city prisoners, for the year 1871, it being the same service formerly performed by the "Physician for the Poor."

The party of the second part agrees to pay said Trustees of said Dispensary the sum of six hundred dollars (\$600) for the performance of the above mentioned services, said amount to be paid as follows, viz.: One hundred and fifty dollars upon the 1st of January, 1871; one hundred and fifty dollars on the 1st of April, 1871; one hundred and fifty dollars on the 1st of July, 1871; and one hundred and fifty dollars on the 1st of October, 1871.
