REGULAR MEETING

Monday, January 5, 1942. 7:30 P. M.

The Common Council of the City of Indianapolis met in the Council Chamber at the City Hall, Monday, January 5, 1942, at 7:30 p. m. in regular session. Joseph G. Wood in the chair.

The Clerk called the roll.

Present: Ollie A. Bach, Harmon A. Campbell, Albert O. Deluse, Dr. Walter E. Hemphill, Ralph F. Moore, F. B. Ransom, Ernest C. Ropkey, Guy O. Ross, Joseph G. Wood.

Mr. Wood announced that the first order of business

would be the election of officers for the year 1942, and asked for nominations for the office of president of the Council.

Mr. Ross nominated Mr. Deluse and the nomination was seconded by Mr. Ransom. Mr. Ropkey made a motion that nominations be closed, which motion was seconded by Mr. Ransom. Mr. Deluse was elected President of the Council by the unanimous vote of the Council.

On invitation of Mr. Wood, President Deluse took the chair.

President Deluse, after a brief address accepting the office of President, called for the next order of business, same being election of Vice-President of the Council.

Mr. Wood made a motion to nominate Mr. Bach. The motion was seconded by Mr. Ross. Mr. Ransom made a motion that the nominations be closed. The motion was seconded by Mr. Wood. Mr. Bach was duly elected Vice-President of the Council by the unanimous vote of the Council.

President Deluse asked for nominations for a member of the Council to serve on the City Plan Commission for the year 1942. Mr. Moore placed the name of Mr. Campbell in nomination. The nomination was seconded by Mr. Bach. Dr. Hemphill made a motion that the nominations be closed and that Mr. Campbell be elected by acclamation. The motion was seconded by Mr. Wood and Mr. Campbell was elected by unanimous vote of the Council.

GENERAL ORDINANCE No. 101, 1941

AN ORDINANCE authorizing the City of Indianapolis to make a temporary loan in the year 1942, in the sum of Twenty Thousand Dollars (\$20,000) for the use of the Board of Health of said city in anticipation of and payable out of the current taxes of said Board of Health actually levied for the Tuberculosis Fund of said board and in the course of collection in the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; providing for legal notice and the time when said loan shall mature; and fixing a time when the same shall take effect.

GENERAL ORDINANCE No. 102, 1941

AN ORDINANCE authorizing the city controller of the City of Indianapolis to make a temporary loan in the sum of Seven Hundred Fifty Thousand Dollars (\$750,000) in anticipation of current taxes of the City of Indianapolis actually levied and in the course of collection for the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; providing for legal notice and the time when said loan shall mature; and fixing a time when the same shall take effect.

GENERAL ORDINANCE No. 103, 1941

AN ORDINANCE authorizing the city controller of the City of Indianapolis to make a temporary loan in the sum of Seventy Thousand Dollars (\$70,000) for the use of the Board of Trustees of the Firemen's Pension Fund of said city, in anticipation of and payable out of the current taxes for the Firemen's Pension Fund actually levied for said fund and in the course of collection for the fiscal year in which said loan is made payable; and fixing a time when the same shall take effect.

GENERAL ORDINANCE No. 104, 1941

AN ORDINANCE authorizing the City of Indianapolis to make a temporary loan in the year 1942 in the sum of One Hundred Twenty-five Thousand Dollars (\$125,000) for the use of the Board of Health of said city, in anticipation of and payable out of the current taxes of said Board of Health actually levied for general Board of Health purposes and in the course of collection for the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; providing for legal notice and the time when said loan shall mature; and fixing a time when the same shall take effect.

GENERAL ORDINANCE No. 105, 1941

AN ORDINANCE authorizing the city controller of the City of Indianapolis to make a temporary loan in the year 1942 in the sum of Twenty-five Thousand Dollars (\$25,000) for the use of the Board of Health of said city, in anticipation of and payable out of the current taxes of the Board of Health actually levied for School Health Fund of said Board and in the course of collection in the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; providing for legal notice and the time when said loan shall mature; and fixing a time when the same shall take effect.

GENERAL ORDINANCE No. 106, 1941

AN ORDINANCE transferring moneys from a certain designated fund in the Department of Public Safety of the City of Indianapolis, Indiana, to a certain other designated fund in said department as the same appear in the 1941 annual budget for said city; and fixing a time when the same shall take effect.

INTRODUCTION OF APPROPRIATION ORDINANCES

By the City Controller:

APPROPRIATION ORDINANCE No. 1, 1942

- AN ORDINANCE appropriating the sum of Thirty-five Thousand Dollars (\$35,000) from certain unappropriated and unexpended balances of the Department of Public Parks of the City of Indianapolis, Indiana, and transferring and allocating the same to a certain designated fund in said department of said city; and fixing a time when the same shall take effect;
- WHEREAS, there exists at this time a sum of money in excess of Eight Thousand Dollars (\$8,000) in the unappropriated and unexpended balance of the Park Land Fund of the Department of Public Parks of the City of Indianapolis, Indiana, which funds have heretofore been derived from the sale of Park land of said city and may, therefore, according to law, be expended only for the improvement or purchase of land for park and park purposes; and
- WHEREAS, there exists at this time a sum of money in excess of Twenty-seven Thousand Dollars (\$27,000) in the unappropriated and unexpended 1941 balance of the Park General Fund of the Department of Public Parks of the City of Indianapolis, Indiana; and
- WHEREAS, an emergency is deemed to exist requiring the transfer and appropriation of the aforedescribed respective sums of

money, aggregating the total sum of Thirty-five Thousand Dollars (\$35,000), all of which said money is to be used for the purchase of certain lands, as more particularly shown and described under Acquisition Resolution No. 1, 1941, adopted by the Board of Park Commissioners on the 21st day of November, 1941; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Eight Thousand Dollars (\$8,000) now in the unappropriated and unexpended balance of the Park Land Fund of the Department of Public Parks, and the sum of Twentyseven Thousand Dollars (\$27,000) now in the unappropriated and unexpended 1941 balance of the Park General Fund, be and the same are hereby transferred, allocated and appropriated from each of said respective funds of the Department of Public Parks of the City of Indianapolis, Indiana, and the aforedescribed sums aggregating the total sum of Thirty-five Thousand Dollars (\$35,000), be and the same hereby are transferred, allocated and appropriated to the following designated fund of said department as per the 1942 budget classification, to-wit:

DEPARTMENT OF PUBLIC PARKS

Fund No. 73-Land.....\$35,000

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

INTRODUCTION OF GENERAL ORDINANCES

By the Board of Public Safety:

GENERAL ORDINANCE No. 1, 1942

AN ORDINANCE establishing a certain passenger and/or loading zone in the City of Indianapolis, pursuant to the provisions of section 26 of General Ordinance No. 96, 1928, as amended by General Ordinance No. 31, 1931, as amended by General Ordinance No. 58, 1931; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That for the purpose of providing the owner or occupant of a certain premise fronting on a certain public street in the City of Indianapolis with ingress and egress for passengers, materials and merchandise coming to or going from such premise, such owner or occupant having complied with the provisions of Section 26 of General Ordinance No. 96, 1928, as amended by General Ordinance No. 31, 1931, as amended by General Ordinance No. 58, 1931, relative to the establishment of passenger and/or loading zones, at the place hereinafter set out, and the Board of Public Safety having caused investigation to be made thereof and having recommended the establishment, pursuant to the terms of the aforesaid ordinance, the following passenger and/or loading zone be and the same is hereby established in the City of Indianapolis, to-wit:

> An 18 foot zone in front of 47 South Pennsylvania Street, said premise being occupied by the Indiana Farm Bureau, and said zone to extend for a distance of 18 feet north of a point starting 25 feet north of the north property line of Maryand Street.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

Which was read the first time and referred to the Committee on Public Safety.
