# INTRODUCTION OF GENERAL ORDINANCES

By the Board of Public Safety:

## GENERAL ORDINANCE No. 2, 1942

AN ORDINANCE establishing a certain passenger and/or loading zone in the City of Indianapolis, pursuant to the provisions of Section 26 of General Ordinance No. 96, 1928, as amended by General Ordinance No. 31, 1931, as amended by General Ordinance No. 58, 1931; and fixing a time when the same shall take effect.

# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That for the purpose of providing the owners or occupants of certain premises fronting on certain public streets in the City of Indianapolis with ingress and egress for passengers, materials and merchandise coming to or going from such premises, such owners or occupants having complied with the provisions of section 26 of General Ordinance No. 96, 1928, as amended by General Ordinance No. 31, 1931, as amended by General Ordinance No. 58, 1931, relative to the establishment of passenger and/or loading zones, at the places hereinafter set out, and the Board of Public Safety having caused investigation to be made thereof and having recommended the establishment, pursuant to the terms of the aforesaid ordinance, the following passenger and/or loading zones be and the same are hereby established in the City of Indianapolis, to-wit:

- (a) An 18 foot zone in front of 108 West Washington Street, said premises being occupied by the Transcontinental & Western Airlines.
- (b) An 18 foot zone in front of 114 West Washington Street, said premises being occupied by the Eastern Airlines.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

# GENERAL ORDINANCE No. 3, 1942

- AN ORDINANCE approving a change in the schedule of taxicab rates by the Red Cab, Inc., and the United Taxi Company, Inc.; and fixing a time when the same shall take effect.
- WHEREAS, on the 13th day of January, 1942, the Board of Public Safety of the City of Indianapolis did approve a change in the schedule of rates of the Red Cab, Inc., and the United Taxi Company, Inc., by changing the schedule of rates previously filed with the Board of Public Safety in accordance to the following schedule of rates:

Twenty-five Cents (\$.25) for the first mile; Ten Cents (\$.10) for each additional four-fifths (4/5) of a mile, and for each three (3) minutes waiting time—Ten Cents (\$.10), with a charge of Two Dollars (\$2.00) per hour for hourly service;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the changes in the schedule of rates of certain taxicab companies, as set out in the preamble of this ordinance and as approved by the Board of Public Safety of the City of Indianapolis, are hereby approved.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

## GENERAL ORDINANCE No. 4, 1942

AN ORDINANCE authorizing the Board of Public Safety of the City of Indianapolis, through its duly authorized purchasing agent, to purchase coal; and fixing a time when the same shall take effect.

# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Board of Public Safety, through its duly authorized purchasing agent, be and it is hereby authorized to receive bids, after duly advertising therefor according to law, and to make purchase of six hundred fifty (650) tons of 6x2 Indiana Forked Egg 5th Vein coal as needed for the various fire stations of the Fire Department of the Department of Public Safety, said purchase not to exceed the sum of Four Dollars and Three Cents (\$4.03) per ton, or the total sum of Two Thousand Six Hundred Nineteen Dollars and Fifty Cents (\$2,619.50).

Section 2. That the purchase shall be made from the lowest and best bidder thereon whose bid has been received after a published advertisement for competitive bids therefor, according to law, and the total cost of the same shall not exceed the sum hereinafter above set out.

Section 3. That the purchase price for said coal shall be paid out of the funds heretofore appropriated to the Department of Public Safety for the year 1942 for said purpose.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

# GENERAL ORDINANCE No. 5, 1942

AN ORDINANCE to amend Section 25 of General Ordinance No. 96, 1928, of the City of Indianapolis, Indiana, as amended, by adding thereto a sub-section (12), and providing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

- Section 1. That Section 25 of General Ordinance No. 96, 1928, of the City of Indianapolis, Indiana, as amended, be and is hereby amended by adding thereto sub-section (12), as follows:
  - (12) Within twenty-five (25) feet of the right of way of any railroad at any grade crossing.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the mayor, and publication according to law.

# INTRODUCTION OF SPECIAL ORDINANCES

## SPECIAL ORDINANCE No. 1, 1942

AN ORDINANCE changing the name of a certain street within the City of Indianapolis, also the name of a certain boulevard both within and without the corporate limits of said city; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

- Section 1. That River Parkway from College Avenue to Pennsylvania Street shall hereafter be known and designated as White River Parkway, North Drive.
- Section 2. That Fifty-ninth Street from Central Avenue to Evanston Avenue shall hereafter be known and designated as Kessler Boulevard, East Drive, which latter name is hereby created as hereinafter provided in Section 5 of this ordinance.

Section 3. That Kessler Boulevard from West Sixteenth Street to West Fifty-sixth Street shall hereafter be known and designated as Kessler Boulevard, North Drive.

Section 4. That Kessler Boulevard from Cooper Avenue to Meridian Street shall hereafter be known and designated as Kessler Boulevard, West Drive.

Section 5. That Kessler Boulevard from Meridian Street to its existing eastern terminus at the intersection of East Fifty-Sixth Street and Fall Creek Parkway, North Drive, shall hereafter be known and designated as Kessler Boulevard, East Drive.

Section 6. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.
