AN ORDINANCE to amend Section 1 of General Ordinance No. 114, 1922, as amended, of the City of Indianapolis, Indiana, commonly known as the Zoning Ordinance; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Section 1 of General Ordinance No. 114, 1922, as amended, be and the same is hereby amended so as to read as follows:

Section 1. District and Zone Map. For the purpose of classifying, regulating and limiting the height, area and use of buildings hereafter to be erected and of regulating and determining the area of front, rear and side yards and other open spaces about buildings and of regulating and determining the use and intensity of use of land and lot areas and of classifying, regulating and restricting the location of trades, callings, industries, commercial enterprises and the location of buildings designed for uses herein specified, the City of Indianapolis, Indiana, is hereby divided into five classes of use districts, termed

respectively class U1 or dwelling house districts, class U2 or apartment house districts, class U3 or business districts, class U4 or first industrial districts, and class U5 or second industrial districts and into four classes of height districts, termed respectively classes H1, H2, H3, and H4; and into nine classes of area districts, termed respectively classes AAA, AA, A1, A2, A2 (b), A3, A4, A5, and A6; all as shown on the district or zone map, which accompanies this ordinance and is hereby declared to be part hereof or in any other manner as shown by an ordinance amendatory or supplementary hereof. The use, height and area districts designated on said zone map are hereby established. The map designations and the map designation rules which accompany said map are hereby declared to be part thereof. No building or premises shall be erected or used except in conformation with the regulations herein prescribed for the use, height and area districts in which such building or premises is located.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, publication, and compliance with the laws pertaining to zoning ordinances.

WHEREAS, in the agreement between the City of Indianapolis and Indianapolis Railways, Incorporated, dated May 25, 1936, amended and approved by General Ordinance No. 40, 1936, said city granted to said Indianapolis Railways, Incorporated, subject to the terms and conditions therein set forth, the right to erect and maintain poles, feeder lines, trolley wires and other structures necessary to the operation of trackless trolley car lines on certain streets and parts of streets named and designated in said agreement, together with such other streets and parts of streets as may from time to time by the Board of Public Works and Sanitation by its written orders be permitted to be used by Indianapolis Railways, Incorporated, for the operation of trackless trolleys, subject to approval of such permits by the Common Council of said city, and to use such streets and parts of streets for transportation of passengers by means of trackless trolley cars; and

WHEREAS, pursuant to said provisions contained in said agreement approved by said General Ordinance No. 40, as amended, for the use of additional streets and parts of streets by Indianapolis Railways, Incorporated, for said trackless trolley purposes, under the terms and conditions of said agreement, said Board of Public Works and Sanitation has, subject to approval by the Common Council, by written order of said board made on the day of June, 1942, granted to Indianapolis Railways, Incorporated, a permit, upon written petition of Indianapolis Railways, Incorporated, permitting said Indianapolis Railways, Incorporated, under the terms and conditions of said agreement, as amended, to use Ohio Street from Illinois Street to Capitol Avenue for operating trackless trolley cars thereon, particularly as part of a route in the downtown district of Indianapolis for the Columbia-Indiana trackless trolley car line of Indianapolis Railways, Incorporated, and to erect thereon the necessary poles and overhead construction; THEREFORE,

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

That the Common Council of the City of Indianapolis does hereby in all things approve, confirm and ratify the aforesaid permit granted on June, 1942, by the Board of Public Works and Sanitation of the City of Indianapolis tò said Indianapolis Railways, Incorporated, pursuant to the provisions of said agreement between the City of Indianapolis and said Indianapolis Railways, Incorporated, dated May 25, 1935, approved, as amended, by General Ordinance No. 40, 1936, permitting said Indianapolis Railways, Incorporated, to use Ohio Street from Illinois Street to Capitol Avenue for operating trackless trolley cars thereon, particularly as part of a route in the downtown district of Indianapolis for the Columbia-Indiana trackless trolley car line of Indianapolis Railways, Incorporated, and to erect thereon the necessary poles and overhead construction. Provided, that use by Indianapolis Railways, Incorporated, of said part of Ohio Street covered by said permit for the aforesaid purposes shall in all things, including duration, be subject to, and in accordance with, all of the terms, conditions and provisions of the aforesaid agreement between the City of Indianapolis and said Indianapolis Railways, Incorporated, dated May 25, 1936, as approved and amended in said General Ordinance No. 40, 1936.
