## APPROPRIATION ORDINANCE No. 10, 1942

AN ORDINANCE creating a "Civilian Defense Emergency Fund" under the control of the Department of Public Safety of the City of Indianapolis, appropriating Twenty-five Thousand Dollars (\$25,000) to said fund from the anticipated unappropriated and unexpended 1942 balance of the general fund of said city, declaring an emergency for such appropriation, and fixing a time when the same shall take effect.

#### GENERAL ORDINANCE No. 44, 1942

AN ORDINANCE authorizing the City Controller of the City of Indianapolis to make a temporary loan in the sum of Seven Hundred Fifty Thousand (\$750,000) in anticipation of current taxes of the City of Indianapolis actually levied and in the course of collection for the fiscal year in which said loan is made payable; providing for the interest to be charged therefor; providing for legal notice and the time when said loan shall mature; and fixing a time when the same shall take effect.

AN ORDINANCE authorizing the city controller of the City of Indianapolis to make a temporary loan in the sum of Seventy Thousand Dollars (\$70,000) for the use of the Board of Trustees of the Firemen's Pension Fund of said city, in anticipation of and payable out of the current taxes for the Firemen's Pension Fund actually levied for said fund and in the course of collection for the fiscal year in which said loan is made payable; and fixing a time when the same shall take effect.

# INTRODUCTION OF GENERAL ORDINANCES

By the Board of Public Safety:

#### GENERAL ORDINANCE No. 55, 1942

AN ORDINANCE requiring the Chicago, Indianapolis and Louisville Railway Company to install and maintain certain safety devices at certain street crossings of the tracks of said company in the City of Indianapolis, Indiana; repealing sections 16 and 19 of General Ordinance No. 102, 1925, repealing a provision in section 1 of General Ordinance No. 122, 1926, and all other ordinances in conflict herewith, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. At the locations where the tracks of the Chicago, Indianapolis and Louisville Railway Company intersect Forty-second, Fifty-Fourth and Sixty-third Streets in the City of Indianapolis, there shall be installed and maintained at each of said crossings, by and at the expense of the Chicago, Indianapolis and Louisville Railway Company, two standard highway crossing signals of the flasher type, one to be set at the southwest corner and one to be set at the northeast corner of each of said locations. At the Forty-second Street location said Railway Company shall also install and operate two short arm gates to operate in conjunction with said flasher signals. All of said installations shall be made in accordance with specifications as approved by the Association of American Railroads and shall be maintained in operation by said Railway Company twentyfour hours a day. Said signals shall be of the automatic type, operated by track circuits, and the City of Indianapolis hereby grants to said Railway Company license and permission to install necessary switches, foundations, poles, crossing signs, flashing lights, and other appurtenances necessary for the operation of said signals and crossing gates.

Section 2. Sections 16 and 19 of General Ordinance No. 102, 1925; the provision relating to the Sixty-third Street location contained in Section 1 of General Ordinance No. 122, 1926, amending Section 653 of General Ordinance No. 121, 1925, and any ordinances or parts of ordinances in so far as the same may be in conflict with the provisions of this ordinance are hereby repealed.

Section 3. This ordinance shall take effect from and after its passage and approval by the mayor.

Section 1. That General Ordinance No. 114, 1922, as amended, commonly known as the Zoning Ordinance of the City of Indianapolis,

be and is hereby amended so that Class U1 or Dwelling House District, the A2(b) or 3600 square foot area district, and the H1 or the 50 foot height district, as therein created, be and are hereby amended, supplemented, extended and restricted so as to include the following described territory:

Townsend's Emerson Addition to the City of Indianapolis, as per plat thereof recorded in Plat Book 26, page 85, in the Office of the Recorder of Marion County, Indiana, which includes all of Lots Nos. 1 through 14, inclusive, (Line on the west side of Emerson Avenue between Elliott Avenue and 14th Street.)

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the mayor, and publication according to law.
