INTRODUCTION OF APPROPRIATION ORDINANCES

APPROPRIATION ORDINANCE No. 2, 1943

- AN ORDINANCE appropriating Twenty-Five Thousand (\$25,000.00) Dollars from the unappropriated and unexpended 1942 balance of the General Fund of the Department of Public Health and Charities and allocating the same to a certain designated fund in said department, and fixing a time when the same shall take effect.
- WHEREAS, there have been reported to the Department of Public Health an increasingly large number of cases of venereal diseases during the past few weeks; and

WHEREAS, the said Department of Public Health is without ade-

quate hospital facilities for the isolation and quarantining of such venereal diseases; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Twenty-Five Thousand (\$25,-000.00) Dollars be and the same is hereby appropriated from the unappropriated and unexpended 1942 balance of the General Fund of the Department of Public Health and Charities to the Isolation Hospital, Division of Venereal Disease Control, Fund Number 26, of said Department.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

APPROPRIATION ORDINANCE No. 3, 1943

- AN ORDINANCE appropriating One Thousand Four Hundred Forty-Eight Dollars and Ninety Cents (\$1,448.90) from the unappropriated and unexpended 1942 balance of the General Fund of the Department of Public Health and Charities, Nurses Training School, Salaries and Wages, Regular No. 11, and allocating the same to a certain designated fund in said Department and fixing a time when the same shall take effect.
- WHEREAS, heretofore as a part of the salary consideration of the Business Manager of the City Hospital, said Business Manager

has been allowed board and lodging at the City Hospital which maintenance and living costs estimated in current money value would be equivalent to approximately One Thousand Four Hundred Forty-Eight Dollars and Ninety Cents (\$1,448.90); and

WHEREAS, the present Business Manager of the City Hospital has elected to live outside of the City Hospital providing his own maintenance and living costs, to offset such expense; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of One Thousand Four Hundred Forty-Eight Dollars and Ninety Cents (\$1,448.90) be, and the same is hereby appropriated from the unappropriated and unexpended 1942 balance of the Department of Public Health and Charities, Nurses Training School, Salaries and Wages, Regular No. 11, to Salaries and Wages, Regular, Business Manager, City Hospital, Fund No. 11, of said Department.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

APPROPRIATION ORDINANCE No. 4, 1943

AN ORDINANCE appropriating Twenty Thousand (\$20,000.00) Dollars from the unappropriated and unexpended 1942 balance of the General Fund of the Department of Public Health and Charities, and allocating the same to a certain designated fund in said Department and fixing the time when the same shall take effect.

WHEREAS, it is found that the present personnel of food inspectors, sanitary officers, etc., is entirely inadequate to meet the demands which have resulted from war and defense activities in the City of Indianapolis; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Twenty Thousand (\$20,000.00) Dollars be and the same is hereby appropriated from the unappropriated and unexpended 1942 balance of the General Fund of the Department of Public Health and Charities to the Administrative Fund No. 11 of said Department.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read the first time and referred to the Committee on Finance.

INTRODUCTION OF GENERAL ORDINANCES

GENERAL ORDINANCE No. 1, 1943

AN ORDINANCE amending General Ordinance No. 61, 1942, regarding the annual budget for 1943 for the Gamewell Division under the Department of Public Safety by reducing the number of Circuit Repairmen and Traffic Signal Repairmen, creating an additional General Foreman at a yearly salary of Three Thousand (\$3,000.00) Dollars; providing for the transfer of certain sums of money from certain numbered funds and reallocating same to other numbered funds; and fixing a time when the same shall take effect.

WHEREAS, by reducing the number of Circuit Repairmen from six (6) to five (5) and the Traffic Signal Repairmen from seven (7) to six (6), and by creating in lieu thereof an additional General Foreman at a yearly salary of Three Thousand (\$3,000.00) Dollars, the efficiency of the Gamewell Division would be increased at a substantial saving to the City; NOW THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the number of Circuit Repairmen provided for in Fund 11, Salaries and Wages, Regular, Gamewell Division of the Department of Public Safety, Annual Budget for 1943, as found in General Ordiance No. 61, 1942, be and the same is hereby amended and reduced to five (5) Circuit Repairmen.

Section 2. That the number of Traffic Signal Repairmen provided for in Fund 11, Salaries and Wages, Regular, Gamewell Division of the Department of Public Safety, Annual Budget for 1943, as found in General Ordinance No. 61, 1942, be and the same is hereby amended and reduced to six (6) Traffic Signal Repairmen.

Section 3. That the number of General Foremen provided for in Fund 11, Salaries and Wages, Regular, Gamewell Division of the Department of Public Safety, Annual Budget for 1943, as found in General Ordinance No. 61, 1942, be and the same is hereby amended and increased to two (2) General Foremen instead of one (1); the salary for the additional General Foreman being provided for hereinafter under Sections 4 and 5 of this ordinance. Section 4. That Two Thousand Forty (\$2,040.00) Dollars of the sum provided for Circuit Repairmen (Tax Levy) in the Annual Budget for 1943, Fund 11, Salaries and Wages, Regular, Gamewell Division of the Department of Public Safety, as found in General Ordinance No. 61, 1942, be and the same is hereby transferred therefrom and reappropriated to Fund 11, of the same division and department, Salaries and Wages, for said one (1) additional General Foreman.

Section 5. That Nine Hundred Sixty (\$960.00) Dollars of the sum provided for Traffic Signal Repairmen, Gas Tax, Fund 11, Salaries and Wages, Regular, Gamewell Division of the Department of Public Safety in the Annual Budget for 1943, as found in General Ordinance No. 61, 1942, be and the same is hereby transferred therefrom and reappropriated to Fund 11 of the same Division and Department, Salaries and Wages, Regular, for said one (1) additional General Foreman.

Section 6. That upon passage of this ordinance, the changes herein provided for shall relate back to and become retroactive in effect as of January 11, 1943.

Section 7. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Which was read the first time and referred to the Committee on Public Safety.
