Beginning at a point two hundred and eighty-four (284) feet from the west curb line of Delaware Street, on the east side of Massachusetts Avenue and exending southwest eighteen (18) feet.

Beginning at a point one hundred and twenty-six (126) feet east of the east curb line of North Pennsylvania Street and extending east eighteen (18) feet on the north side of East Market Street.

Section 2. This ordinance shall be in full force and effect from and after passage and approval by the Mayor.

- WHEREAS, this body deems that an emergency now exists which demands prompt action on the part of parties responsible for the enforcement of said laws and ordinances;
- THEREFORE, BE IT RESOLVED, by the Common Council of the City of Indianapolis, Indiana, that the President of the Common Council is hereby empowered to appoint a committee of three (3) members of the Common Council to investigate such conditions as they exist and to report to the Common Council within thirty (30) days;

- BE IT FURTHER RESOLVED, that said committee shall have full authority to investigate any department of the City concerned with the enforcement of such ordinances and laws; subpoena witness and records of said departments; make recommendations as to proposed changes in City Ordinances affecting the same;
- BE IT FURTHER RESOLVED, that the City Clerk, as Clerk of Common Council be and is hereby designated as Clerk of said committee with full authority, as provided by the statutes of the State of Indiana, to serve said subpoenas upon any employee of the City of Indianapolis, any person residing within the City of Indianapolis or upon any officer of any corporation located within said City.
