assessments and the consequent stoppage of interest by operation of law or by the failure to collect interest to the due date of the prepaid installments thereof; and because of the diversion of certain funds paid on one improvement roll and account to the payment of bonds and coupons chargeable to another roll and account; and because of the loss of certain Barrett Law funds by the closing and insolvency of certain banks in which said funds were on deposit; and because of certain other diversions or misapplication of certain of such funds, resulting in the non-payment of certain bonds and coupons to which such collected funds should have been applied, not provided for in existing budgets and levies; and fixing a time when the same shall take effect.

WHEREAS, by General Ordinance No. 84-1943, duly passed by the Common Council of the City of Indianapolis and approved by the Mayor of said City, the provisions of which are hereby included herein by this reference thereto, certain Barrett Law Deficiency Bonds of the City of Indianapolis, aggregating a principal amount of Five Hundred Sixty Thousand Seven Hundred Ninety-five Dollars and Eighty-three Cents (\$560,795.83), were authorized to be issued and sold to provide funds for the payment of deficiencies in the various improvement funds, arising because of prepayment of assessments and the consequent stoppage of interest by operation of law or by the failure to collect interest to the due date of the prepaid installments thereof; and because of the diversion of certain funds paid on one improvement roll and account to the payment of bonds and coupons chargeable to another roll and account; and because of the loss of certain Barrett Law funds by the closing and insolvency of certain banks in which said funds were on deposit; and because of certain other diversions or misapplication of certain of such funds, resulting in the non-payment of certain bonds and coupons to which such collected funds should have been applied, arising on account of portions of Barrett Law bonds and coupons maturing subsequent to January 1, 1929, for which no provision has been made in the existing budget and tax levies and for the payment of which no funds are now available; and accordingly the Common Council now finds that an extraordinary emergency now exists for such purpose and to preserve the credit of the City of Indianapolis; NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the proceeds derived from the sale of City of Indianapolis Barrett Law Deficiency Bonds, pursuant to the authority granted by and under General Ordinance No. 84-1943, are hereby appropriated to and for the use of the Department of Finance for the purpose of paying and cancelling all liability of the City of Indianapolis on account of the deficiencies in Barrlett Law Funds arising because of prepaying of assessments and the stoppage of interest by operation of law or the failure to collect interest to the due date of prepaid installments thereto, and because of the diversion of any funds paid on one improvement roll and account to the payment of bonds and coupons chargeable to another roll and account; and because of other diversions and misapplications of such funds collected and consequent non-payment of the bonds and coupons to which such collected funds should have been applied; and because of the deficiencies in Barrett Law funds arising on account of the closing and insolvency of certain banks in which such funds were on deposit; all on Barrett Law bonds and coupons maturing subsequent to January 1, 1929; payments to be made out of such funds to the persons and under the assessment rolls and schedules in such amounts as are set out and established by a certain audit made and completed by the City Controller and representatives of the State Board of Accounts, a copy of which audit is on file in the office of the City Controller of the City of Indianapolis. Any surplus of such proceeds remaining after the payment of all liabilities fixed in and by said audit shall be credited to the General Sinking Fund of the City of Indianapolis, as provided by law.

Section 2. Immediately upon the final passage and approval of this ordinance and determination, the City Clerk and the City Controller shall deliver two (2) certified copies thereof to the auditor of Marion County with the request that a copy thereof be certified and transmitted immediately by him to the State Board of Tax Commissioners for further action thereon as provided by Chapter 150 of the Acts of the General Assembly of 1935.

Section 3. This ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.
