GENERAL ORDINANCE No. 52, 1944

AN ORDINANCE amending Section 4 of General Ordinance No. 51, 1937, to require the drivers of all taxicabs to remain in the driver's seat of their taxicabs, when same are parked or standing in a Taxicab Stand; Providing a penalty for violation thereof; and fixing the time when the same shall take effect.

Section 2. Any person violating any of the provisions of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00) to which may be added imprisonment not to exceed One Hundred Eighty (180) days.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication according to law.

"18 foot 'loading zone' on the west side of Capitol Avenue starting at a point 182 feet north of the north curb line of Georgia Street and extending north for a distance of 18 feet." "18 foot 'loading zone' starting at a point 25 feet south of the south curb line of East Morris Street on the west side of Charles Street and extending south for a distance of 18 feet."

Section 3. That this ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
