AN ORDINANCE regulating traffic on Cleveland Street in the City of Indianapolis so as to provide for north and south bound traffic in said street between the intersections of Ohio and Vermont Streets and repealing all ordinances and/or parts of ordinances in conflict therewith; Prohibiting parking at all times on a certain part of Scuth Illinois Street in said City and providing a penalty for violation thereof; fixing a time when this ordinance shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That traffic on Cleveland Street in the City of Indianapolis be and the same is hereby regulated to provide for north and south bound traffic on said street between the intersections of Ohio and Vermont Streets and all ordinances and/or parts of ordinances in conflict therewith are hereby repealed.

Section 2. That it shall be unlawful for the operator of any vehicle to have the same or suffer, permit or allow the same to be parked at any time upon the following part of South Illinois Street in said City, to-wit:

"On the east side of South Illinois Street from the south curb line of Maryland Street south for a distance of ninety (90) feet."

Section 3. Any person violating Section 2 of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00) to which may be added imprisonment not exceeding one hundred eighty (180) days.

Section 4. This ordinance shall be in full force and effect upon its passage, approval by the Mayor, and publication according to law.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That General Ordinance No. 114, 1922 (as amended), commonly known as the Zoning Ordinance of the City of Indianapolis,

be and the same is hereby amended, supplemented and extended as to U2 or Apartment District, A4, or 1,200 sq. ft. area; H1, or 50 ft. height, so as to include the following described territory, to-wit:

Beginning at the intersection of the north line of West Tenth Street and the west line of West Street and running thence west along the said north line of West Tenth Street, extended west to the southwest line of Stadium Drive; thence in a northwesterly direction on the said southwest line of Stadium Drive to the north line of Speedway Avenue; thence west with the said north line of Speedway Avenue to a point, said point being the intersection of the said north line of Speedway Avenue and the east line of Hiawatha Street extended south; thence north, along the said east line of Hiawatha Street extended. to the south line of the first alley north of Stadium Drive; thence east, on said south line of the first alley north of Stadium Drive, to the west bank of Fall Creek; thence north, northeast and northwest with the meanderings of said west bank of Fall Creek to the south line of West 16th Street, as established by Resolutions No. 15102 and No. 15102 A and B of the Board of Public Works & Sanitation, adopted October 4, 1933; thence in an easterly direction along the said south line of West 16th Street to a point, said point being five hundred thirty (530) feet west of the west line of Brighton Boulevard; thence south, at right angle to said south line of West 16th Street, a distance of one hundred seventy (170) feet to a point; thence east, on a line parallel to and one hundred seventy (170) feet distant from, said south line of West 16th Street, to a point, said point being one hundred sixty (160) feet west of the west line of West Street, produced north into Brighton Boulevard; thence south in a line parallel with and one hundred sixty (160) feet distant from said west line of West Street, to the north line of West 14th Street; thence east along the said north line of West 14th Street to the west line of West Street; thence south along the said west line of West Street to the north line of West 10th Street, the place of beginning.

Section 2. That General Ordinance No. 114, 1922 (as amended), commonly known as the Zoning Ordinance of the City of Indianapolis, be and the same is hereby amended, supplemented and extended as

to U3 or Business District, A4, or 1,200 sq. ft. area; H1, or 50 ft. height, so as to include the following described territory, to-wit:

Beginning at the intersection of the west line of Brighton Boulevard and the south line of West 16th Street, as established by Resolutions No. 15102 and No. 15102 A and B of the Board of Public Works & Sanitation, adopted October 4, 1933; thence running west along the said south line of West 16th Street, a distance of five hundred thirty (530) feet to a point; thence south at right angle to the said south line of West 16th Street, a distance of one hundred seventy (170) feet to a point; thence east on a line parallel to and one hundred seventy (170) feet distant from said south line of West 16th Street, to a point, said point being one hundred sixty (160) feet west of the west line of West Street, produced north into Brighton Boulevard; thence south on a line parallel to and one hundred sixty (160) feet distant from said west line of West Street, to the north line of West 14th Street; thence east along the said north line of West 14th Street, to the west line of West Street; thence north along the said west line of West Street to the southwest line of Brighton Boulevard; thence in a northwesterly direction, along the said southwest line of Brighton Boulevard, to the south line of West 16th street, the place of beginning.

Section 3. The ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.
