# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That there is hereby established and set up in the Police and Fire Departments and the Gamewell Division of the Department of Public Safety of the City of Indianapolis, for the purposes hereinafter enumerated and provided, a special fund hereby designated and to be known as "Policemen and Firemen Equipment Fund;" that the funds as hereinafter transferred and reappropriated to said special fund are for the following purposes, to-wit:

For the payment of the sum of Sixty Dollars (\$60.00) as uniform, clothing and equipment allowances to each and every member of the Indianapolis Police and Fire Department (including such members as are attached to and serving with the Gamewell Division, as well as policewomen and plain clothes detectives) who has been a member for the last past twelve (12) months or longer; and the payment of a sum equivalent to Five Dollars (\$5.00) per month for each month of membership during the last past twelve (12) months period to each and every member of the aforesaid department who has been a member for less than twelve (12) months.

Section 2. That for the purposes set out and provided for in Section 1 of this ordinance, the following sums are hereby transferred, reallocated and reappropriated from Fund No. 11, Salaries and Wages, Regular, as said fund now exists in the 1944 Budget for the City of Indianapolis in certain departments of the Department of Public Safety of the City of Indianapolis, to a special fund hereby established and designated as, "Policemen and Firemen Equipment Fund" in aforesaid certain departments of the Department of Public Safety of the City of Indianapolis, as follows, to-wit:

# DEPARTMENT OF PUBLIC SAFETY FIRE DEPARTMENT

From Fund No. 11, Salaries and Wages, Regular, the sum of Thirty-One Thousand Dollars (\$31,000.00) is hereby transferred, reallocated and reappropriated to special fund, "Policemen and Firemen Equipment Fund".

# DEPARTMENT OF PUBLIC SAFETY POLICE DEPARTMENT

From Fund No. 11. Salaries and Wages, Regular, the sum of Thirty-Two Thousand Dollars (\$32,000.00) is hereby transferred, reallocated and reappropriated to special fund, "Policemen and Firemen Equipment Fund".

# DEPARTMENT OF PUBLIC SAFETY GAMEWELL DIVISION

From Fund No. 11, Salaries and Wages, Regular, the sum of Three Hundred Dollars (\$300.00) is hereby transferred, reallocated and reappropriated to special fund, "Policemen and Firemen Equipment Fund".

Section 3. That the City Controller of the City of Indianapolis, Indiana, be and the same is hereby authorized, empowered and directed to pay such sums of money to the respective members of the Police and Fire Departments and the Gamewell Division of the Department of Public Safety of the City of Indianapolis, on or before the 30th day of December, 1944, in the manner provided in the foregoing sections of this ordinance.

Section 4. That any and all ordinances, including Appropriation and General Ordinances, in conflict with any of the provisions of this ordinance are hereby repealed.

Section 5. That this ordinance shall be in full force and effect from and after its passage, approval by the Mayor and compliance with all laws pertaining thereto.

## INTRODUCTION OF GENERAL ORDINANCES

By Councilman Brown:

GENERAL ORDINANCE No. 92, 1944

AN ORDINANCE for the purpose of making available license tags for dogs known as "War Dog" discharged from the various military services of the government of the United States of America at a nominal fee; repealing all ordinances in conflict therewith; and providing a time when the same shall take effect.

BE II ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That license tags for all dogs known as "War Dogs" which have been discharged from any of the various military services of the United States of America, owned, maintained and kept within the City of Indianapolis, by persons who are bona fide residents of said City, shall be issued to said owners upon application to the City Controller of said City by said City Controller upon payment of a fee of twenty-five (25) cents.

Section 2. That said license tags issued according to the provisions of Section 1 of this ordinance shall be for the life of said dog and shall not be transferrable to any other dog.

Section 3. That before any such license tag shall be issued to any owner of a "War Dog," said owner shall submit evidence to the clerk issuing such license, that his or her dog has actually served in the military service and has been discharged therefrom.

Section 4. Any ordinance or parts of ordinances in conflict herewith are hereby repealed. Provided, however, that this ordinance shall in no way affect the provisions of any ordinances relating to license tags for other than "War Dogs".

Section 5. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

# GENERAL ORDINANCE No. 93, 1944

AN ORDINANCE ratifying and approving a certain contract by and between the City of Indianapolis, Marion County, Indiana, by and through its Board of Public Safety, with the approval of its Mayor, and Town of Woodruff Place, Marion County, Indiana, by and through its Board of Trustees, entered on the 28th day of November, 1944; and fixing a time when this ordinance shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That a certain contract by and between the City of Indianapolis, by and through its Board of Public Safety, with the approval of its Mayor, and Town of Woodruff Place, by and through its Board of Trustees, entered into on the 28th day of November, 1944, which contract reads as follows, to-wit:

THIS AGREEMENT, made and entered into this 28th day of November, 1944, by and betwen the City of Indianapolis, Marion County, Indiana, by and through its BoBard of Public Safety, with the approval of its Mayor, party of the first part, and the Town of Woodruff Place, Marion County, Indiana, by and through its Board of Trustees, party of the second part, WITNESSETH, that:

WHEREAS, the party of the first part does maintain and possess a Police Department and a Fire Department for police and fire protection of its residents, and is desirous of contracting with the party of the second part for the use of the services of the Police and Fire Departments belonging to the party of the first part; and

WHEREAS, the party of the second part has no police and fire departments for the use and benefit of its residents and is, therefore, desirous of contracting with the party of the first part for the use of the police and fire departments belonging to the party of the first part, said use to be in the nature of the police and fire departments of the party of first part rendering the same protection and service to the party of the second part as they now render and will render to party of the first part;

NOW, THEREFORE, THIS AGREEMENT WITNESSETH:
The party of the first part does hereby agree to furnish
the same police and fire protection to the party of the second
part which said party of the first part now receives and will
receive from its own police and fire departments, in consideration

of the sum of Seventy-Five Hundred Dollars (\$7,500.00) per year for the year beginning January 1, 1945, to and including December 31, 1945, paid to the party of the first part by the party of the second part.

The party of the second part hereby agrees to pay to the party of the first part for the said police and fire protection rendered the sum of Seventy-Five Hundred Dollars (\$7,500.00) in four (4) equal quarterly payments, as follows: One Thousand Eight Hundred Seventy-Five Dollars (\$1,875.00) as due and payable on the first day of each of the following months: January, April, July and October of the year 1945. The second party agrees to aid in the matter of fire protection by conforming to the building code of the first party now established, in so far as the party of the second part can lawfully do so. It is agreed and understood by and between both parties hereto that this contract shall be in full force and effect for the period of one (1) year, that is, from the first day of January, 1945, to the 31st day of December, 1945.

It is further agreed and understood by and between the parties hereto that no liability attaches or will attach to the party of the first part on account of the nature of the work and services performed by said police and fire departments of the party of the first part. And said second party hereby assumes and agrees to pay and indemnify said first party against any liability incurred by first party on account of any loss or damage sustained, either to persons or property, by any person whomsoever in carrying out the terms and provisions of this contract and agreement, including any liability to the Town of Woodruff Place, citizens of the Town of Woodruff Place, members of the public, employees of first and second parties, and all other persons.

It is further agreed and understood that the party of the second part shall furnish its own water supply at its own expense. This contract, on the part of the City of Indianapolis, shall be of no force and effect unless specifically authorized by ordinance passed by the Common Council of the City of Indianapolis and approved by its Mayor.

A group of representative citizens met at a luncheon meeting held at the Flanner House on West 16th Street, December 1, 1944. The following persons were present at the meeting: Messrs. Norman Isaacs, Lewis E. Evans, F. E. DeFrantz, Lionel Artis, Harry V. Wade, Thomas Harner, W. Roland Allen, William Rothenburger, Henry Ostrom, Roger Benjamin, F. E. Gates, F. B. Ransom, John Schumacher, Herman Bowers, W. J. Boothe, Cleo Blackburn, Otto Worley, Doctors Paul Batties, Charles Myers, R. B. McArthur, Herman G. Morgan, Lucian Meriwether, Rev. R. T. Andrews, and Mrs. Meredith Nicholson, Jr.

The meeting was called for the purpose of discussing a historical review of the work which Flanner House had conducted in the community for the past forty-seven years, including the cooperating program with the City Health Department in conducting health clinics for the past thirty-five years.

The need for extending the activities of the health center program. The request for federal funds to erect and equip a new building for augmenting the program.

A progressive report on the request for a grant from the federal government and the city's contribution as a match fund in order to secure the federal grant.

The report that the government had authorized a grant for \$74,000.00 which would require an appropriation of \$56,000.00 on the part of the city to assist in erecting and equipping a new building.

A general discussion as to what scope the health center was expected to cover, and the definite understanding of those present that its activities would be confined entirely to the work and program of a health center conforming to the program which had been conducted for the past thirty-five years.

At the conclusion of the meeting, Mr. Harry V. Wade, moved that this public meeting go on record as indorsing a diagnostic and health center, and with definite understanding that such a center should not be limited to any class, race, or creed. The motion was seconded by Mr. F. E. DeFrantz, and unanimously carried by consent.

It was suggested by those present that the Chairman of the meeting, Doctor Herman G. Morgan, be requested to inform the City Council of the motion which had been passed, and that publicity be released on Monday, December 4, 1944, relative to the meeting and the program which had been discussed along with the final decision reached at the public meeting.

Which was seconded by Mr. Dauss and was passed by the unanimous vote of the Council.

On motion of Mr. Kealing, seconded by Mr. Bowers, the Common Council adjourned at 9:00 p. m.
