COMMON COUNCIL.

REGULAR SESSION.

CHAMBER OF THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, Monday, August 31st, 1868, 7½ o'clock, P. M.

The Common Council met in regular session.

Present—His Honor, the Mayor, Daniel Macauley, in the chair, and the following members:

Councilmen Brown, Coburn, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, Seidensticker and Woodburn-13.

Absent—Councilmen Burgess, Colley, MacArthur, Schmidt and Stanton—5.

The proceedings of the regular session held Aug. 24th, 1868, were read and approved.

REGULAR ORDER OF BUSINESS.

Mr. Brown presented the following petition:

INDIANAPOLIS, Aug. 31, 1868.

To the Mayor and Common Council of the City of Indianapolis:

Your petitioners respectfully petition your honorable body to provide by ordinance for the grading and graveling of the alley running north and south through Square 96, on the west bank of Pogue Run, and for protecting the embankment of said alley along the line of Pogue Run by a stone wall.

Which was received.

Also, special ordinance No. 86-1868, entitled :

AN ORDINANCE to provide for securing the embankment and grading and graveling the alley in Square 96, on the west bank of Pogue Run, between South and McNabb streets.

Which was read the first time.

Mr. Cottrell offered the following resolution :

Resolved, That the Chief Fire Engineer be, and is hereby, ordered to require all persons connected with the Fire Department and receiving pay for services as such, to abstain from any and all employment by which they are required to be absent from the duties of the Department.

Resolved, That a failure, on the part of any employee, to comply with the requirement as above, will be recognized as a resignation of his position in the Department, and another be appointed in his stead.

The question being on the adoption of the resolution. those who voted in the affirmative were Councilmen Brown, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Seidensticker and Woodburn—11.

Councilman Loomis voting in the negative.

So the resolution was adopted.

Mr. Davis offered the following motion :

That the Chief Fire Engineer be, and is hereby, directed to dispense with the services of the men now employed in the Tower, and to remove the bell from that point to the No. 2 Engine House, and to place it on a tower of like construction to the one where the bell now is.

A division of the question being called for, the first part, dispensing with the services of the men on the tower, was adopted.

In reference to the second part of the motion, Mr Seidensticker offered the following motion:

To refer to Committee on Fire Department with instructions to solicit bids for erecting a wooden tower on No. 2 Engine House, and report which place is, in their opinion, the best, and, also, to dispose of the old tower in the most advantageous manner

Which was adopted.

Mr. Davis offered the following motion :

That the Street Commissioner be directed to properly open the gutters on South Tennessee street, between Merrill and Garden streets, so that the water can be taken from Tennessee street, and that the Civil Engineer be directed to set the proper grade stakes.

Which was adopted.

Mr. Foster presented the following petition :

INDIANAPOLIS, Aug. 31, 1868.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:--I am compelled to again call your attention to my contract with the City for grading and graveling of South Tennessee street, between Garden and McCarty streets.

The late James Wood, Esq., Civil Engineer, set stakes on the crossings of Garden and McCarty streets, with instructions to grade and gravel said crossings. It being my contract to do the work according to the instructions of the Civil Engineer, the work was done. The work has lately been measured by Mr. Staples, Civil Engineer, and still later by Mr. Patterson, the present City Civil Engineer, and not being satisfied with their measurement, I am willing to dig holes to the old surface at my own expense, that the City may have the work properly measured both to the satisfaction of the City and to myself. I trust something will be done at once, and thus I will ever pray, &c., &c. THOMAS WREN,

Which was referred to the Board of Public Improvements and Civil Engineer, with instructions to examine the matter and report:

Mr. Geisel offered the following motion :

That Frederick Kessler be permitted to grade and gravel the sidewalk on Arch street in front of lot Nos. 1, 2 and 3, near Plum street, under the direction of the Civil Engineer.

Which was adopted.

Mr. Goddard offered the following motion :

That Mr. Robinson and Mr. Ogdon be allowed to pave with brick 15 feet wide in front of their premises on Washington street, between Missouri and West sts., on the south side, at their own expense.

Which was adopted.

Mr. Henschen offered the following motion :

That the Street Commissioner be instructed to bowlder the gutter on the crossing of Harrison street and Forest Avenue.

Which was adopted.

Mr. Henschen, also, offered the following motion :

That the City Clerk be directed to advertise the ordinance for the re-graveling of Noble street, between Washington street and the Central Railroad.

Which was adopted.

Mr. Henschen, also, offered the following motion :

That the Market Master repair the gates in the West Market House.

Which was adopted.

Dr. Jameson introduced special ordinance No. 87-1868, entitled:

AN ORDINANCE to provide for paving the west sidewalks of New Jersey street, between Massachusetts Avenue and Walnut street.

Which was read the first time.

Dr. Jameson presented the following petition:

INDIANAPOLIS, Aug. 31, 1868.

To the Mayor and Common Council of the City of Indianapolis:

My daughter, Mrs. Vance, requests permission to curb with stone, and pave with hard brick ten feet wide, the sidewalk in front of her property on Market street, between Alabama and New Jersey streets, west of the alley about 104 feet, and that the City Engineer be directed to set the necessary grade marks. Or, if the brick pavement has already been ordered and contract let, then the

permission will only be for the stone curb. She would prefer, however, to do the whole if she can do so without conflicting with any order already made in reference to it. H. BATES.

Dr. Jameson, also, presented the following petition :

Which was adopted.

Mr. Kappes offered the following motion:

That the Indianapolis Educational Society be allowed to grade and pave with brick the sidewalk in front of their property on Michigan street, and that the Civil Engineer be, and is hereby, directed to set the grade stakes.

Which was adopted.

Mr. Kappes, also, offered the following motion :

That David Macy and Thomas V. Malott be allowed to grade and pave with brick the sidewalks in front of their premises on North Delaware street and on the south side of North street, between Delaware and Pennsylvania streets, and that the Civil Engineer be, and is hereby, directed to set the necessary grade stakes.

Which was adopted.

Mr. Loomis presented the following petition :

Dr. Woodburn presented the following remonstrance:

INDIANAPOLIS, Aug. 27, 1868.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN: --- We, the undersigned property owners on Mississippi street, between Washington and Market streets, would respectfully but earnestly remonstrate against the passage of an ordinance now pending before your honorable body for the grading and paving of the west sidewalk on Mississippi street, between the points above named, as in our opinion said improvement is not necessary at present, and further that some of us are not able to pay for said improvement if done, &c. DEAR SIR:—Some weeks ago a petition was given the Council for grading and graveling our street (Fayette), which was granted. I understand that the vacant lot owners will present a remonstrance this evening. We, who have built and live on the street, desire the work done, and do not think capitalists and others who own vacant lots on said street should rule in this case. You can vote as you please, but I understand the Council has the right to order it if it wishes. There is a very muddy pond close to my house, in said street, and I want the work done.
