The Common Council met in regular session.

The proceedings of the regular session held Sept. 7th, 1868, were read and approved.

Business was resumed in the order in which it was left off at last meeting, viz :

REPORTS FROM CITY OFFICERS.

The Street Commissioner made the following report :

INDIANAPOLIS, Sept. 7, 1868.

To the Mayor and Common Council of the City of Indianapolis :

The Street Commissioner would respectfully submit the following monthly report of all the work done from August 10, 1868, up to date :

1. Cleaned Illinois street between Market and Louisiana streets.
2. Cleaned Washington street between Noble and Missouri streets.

3. Cleaned Tennessee street between Market and Washington streets.
4. Cleaned Market street between Alabama and Delaware streets.
5. Rebowldered and widened the crossing on Indiana Avenue and Mississippi street.
6. Opened the gutters on Russell street between Illinois and Meridian streets.
7. Opened the gutters on Merrill street between Pennsylvania and Meridian streets.
8. Opened the gutters on Meridian street between South and McCarty streets.
9. Opened the gutters on East street between South and Louisiana streets.
10. Opened the gutters on South street between Tennessee street and the Canal.
11. Opened the gutters on Mississippi street between Georgia and South streets, east side.
12. Opened the gutters on Louisiana street between Tennessee and Mississippi streets, north side.
13. Opened the gutters on Bluff Road between McCarty and Ray streets.
14. Opened the gutters on Illinois street between McCarty st. and Pogue Run.
15. Opened the gutters on Tennessee street between McCarty street and Pogue Run.
16. Built a culvert on Pennsylvania and Court streets.
17. Built two culverts on New Jersey and Ohio streets.
18. Rebuilt a culvert on New Jersey and Vermont streets.
19. Built a culvert on Madison Avenue with intersection of Madison Railroad.
20. Cleaned and repaired the culverts on Illinois street with the intersection of Washington street and Kentucky Avenue.
21. Laid one foot bridge on Pennsylvania street between Market and Washington streets.
22. Built an entirely new bridge on South street across the Canal.
23. Graded and graveled the sidewalks on Massachusetts Avenue between Liberty and Noble streets.
24. Bowldered the alley crossings on North street between Alabama and Delaware streets, on the north side.
25. Took up and rebowldered the gutter on Illinois street, between Market and Washington streets, and 70 feet on Market street, southeast side.
26. Put two wooden protection walls on South street and Pogue Run.
27. Filled the crossings on Russell and Meridian streets with gravel.
28. Filled the gutters on Alabama street, between North and Michigan streets, with gravel.
29. Filled the mud holes on Tennessee street, between Louisiana and Georgia, with spalts and gravel.
30. Took up and re-bowldered the alley running north and south in Square 56.
31. Filled the crossings on East and St. Clair streets with gravel.
32. Filled the crossings on Michigan and Railroad streets with gravel.
33. Filled the crossings on Louisiana and Mississippi streets with spalts.
34. Filled four alley crossings on Illinois street, between Vermont and St. Clair streets, with spalts and gravel, west side.
35. Repaired the gutters on Washington street between Alabama and Delaware streets.
36. Filled up the end of the bridge on Illinois street across Pogue Run with spalts and gravel.
37. Raised the sidewalks on Market street, between Alabama and Delaware sts., with gravel.
38. Repaired the bridge on South street across Pogue Run.
39. Cut the grass and cleaned the Governor's Circle.
40. Bowldered the crossing on Harrison street with the intersection of Forrest Avenue.

INDIANAPOLIS, Sept. 14, 1868.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—The Street Commissioner would respectfully report to the Common Council:

1st. That Richard Carr, the contractor for repairing Delaware street, between South and Wyoming streets, has completed the same, and has placed thereon 1443 yards of gravel at \$1.10 cents per yard, making the sum of fifteen hundred dollars and eighty-seven cents to be assessed against the property on each side of the line improved between the points named in his contract.

2d. That Hiram Seibert, the contractor for repairing Merrill street and sidewalks between Delaware and Alabama streets, has completed the same, and has placed thereon 214 yards of gravel at \$1.10 cents per yard, making the sum of two hundred and thirty-five dollars and forty cents to be assessed against the property on each side of the line improved between the points named in his contract.

ORDINANCES ON THIRD READING.

Mr. Loomis called up general ordinance No. 159—1868, entitled :

AN ORDINANCE granting the petition of the Indianapolis, Cincinnati and Lafayette Railroad Company for crossing with side tracks Alabama and Delaware sts.

By unanimous consent, Dr. Jameson offered the following amendment to the ordinance :

Sec. —. If the said Railroad refuse or fail to comply with all the provisions of this ordinance, at all times, the City reserves the right to remove all of said tracks from the street.

Which was unanimously adopted.

The ordinance was then read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Davis, Foster, Geisel, Goddard, Jameson, Kappes, Loomis, MacArthur, Seidensticker and Woodburn—12.

Those who voted in the negative were Councilmen Cottrell, Henschen and Schmidt—3.

So the ordinance passed.

Dr. Woodburn called up special ordinance No. 78—1868, entitled :

AN ORDINANCE to provide for grading and paving with brick the sidewalk on the north side of Market street, between Illinois and Tennessee streets.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—15.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Loomis called up special ordinance No. 85—1868, entitled :

AN ORDINANCE to provide for leveling and re-graveling Virginia Avenue, between Stevens street and the Corporation line.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Cottrell, Davis, Fos-

ter, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—15.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Davis called up special ordinance No. 81—1868, entitled :

AN ORDINANCE to provide for grading and graveling Muskingum alley, between St. Clair and Pratt streets, including the sidewalk.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—15.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Geisel called up special ordinance No. 79—1868, entitled :

AN ORDINANCE to provide for grading Vine street and sidewalks from Jackson street to the first alley east of Ash street.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—15.

No Councilman voting in the negative.

So the ordinance passed.

Mr. Geisel called up special appropriation ordinance No. 42—1868, entitled :

AN ORDINANCE appropriating money for the payment of sundry claims against the City of Indianapolis.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—15.

No Councilman voting in the negative.

So the ordinance passed.

Mr. MacArthur called up special ordinance No. 76—1868, entitled:

AN ORDINANCE to provide for grading, paving and curbing the outside edge of the sidewalk with white oak plank, the west sidewalk on Mississippi street, from Wabash to Market streets.

Which was read the third time and placed upon its passage.

The question being, shall the ordinance pass? those who voted in the affirmative were Councilmen Brown, Coburn, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Jameson, Kappes, Loomis, MacArthur, Schmidt, Seidensticker and Woodburn—15.

No Councilman voting in the negative.

So the ordinance passed.

UNFINISHED BUSINESS.

On motion by Mr. Brown, the vote awarding the contract to Feary & Dillon to build a sewer from Delaware street to Pogue Run, along the line of Ray street, was reconsidered.

The ayes and noes were demanded upon the motion awarding the contract.

Those who voted in the affirmative were Councilmen Brown, Cottrell, Davis, Foster, Geisel, Goddard, Henschen, Loomis, Schmidt and Seidensticker—10.

Those who voted in the negative were Councilmen Coburn, Jameson, Kappes, MacArthur and Woodburn—5.

So the motion was adopted.

Dr. Jameson offered the following motion:

That the Street Commissioner be directed to suspend all further repairs (except the stopping of holes in bridges and culverts) till further directed by the Council.

Which was referred to the Board of Public Improvements.

Dr. Jameson, also, offered the following motion:

That Smith, Harlan & Co. be permitted to bowlder the sidewalk adjacent to their building near the crossing of Massachusetts Avenue and Alabama street.

Which was adopted.

Also, the following motion:

That Frederick Ritzinger, B. E. Voigt, Adolph Schellschmidt and Wm. Langskamp be permitted to set stone curbing and pave with brick 9 feet of the inner edge of the sidewalk in front of their property on Ohio street, between East and

New Jersey streets, provided the same be done under the direction of the Civil Engineer, and that the Street Commissioner be directed to have the City's portion of the same work contracted for at the same time.

Which was adopted.

His Honor, the Mayor, offered the following resolution :

Resolved, That the City of Indianapolis authorize the offering of the sum of one thousand (1,000) dollars as a reward for the detection and capture of the murderer or murderers of Mr. and Mrs. Young, near the city limits, last Saturday, September 12th, 1868.

Which was referred to the City Attorney.

Mr. Seidensticker presented the following petition :

INDIANAPOLIS, Sept. 14, 1868.

To the Mayor and Common Council of the City of Indianapolis:

GENTLEMEN:—We, the undersigned, citizens and property holders residing on the corner of Christian Avenue and Jackson street, and on said street south of said Avenue to the Corporation line of the City of Indianapolis, would respectfully represent to your honorable body that by reason of the recent grading of said Jackson street, under the direction and authority of the City of Indianapolis, that we have been deprived of our natural drainage, and that as the result of said grading a large and disagreeable pond of water is kept standing without any outlet, not only on our lots, but immediately in front of our doors, and that it is now, and will remain if not removed, not only impassable for persons on foot but exceedingly deleterious to the health of our neighborhood.

The drawing or plat hereto attached represents the locality and manner in which we are affected. We therefore respectfully petition your honorable body to refer our request to the proper committee, or person, with the view of an immediate inspection of the premises, and that we may have such relief as may be just in the premises.

Mr. Loomis introduced special ordinance No. 91—1868, entitled :

AN ORDINANCE to provide for grading and graveling the alley running east and west, being one half of the south alley in Square 94, between School, Huron, Noble and South streets.

Which was read the first time.

Mr. Brown introduced special ordinance No. 92—1868, entitled :

AN ORDINANCE to provide for repairing the bowldered pavement on Louisiana street, between Meridian and Illinois streets.

Which was read the first time.

Mr. Davis introduced special ordinance No. 93—1868, entitled :

AN ORDINANCE to provide for grading and graveling the alley running north and south, between New Jersey and High streets, and between Bicking street and Noble's estate.

Which was read the first time.

Mr. Cottrell offered the following motion :

That the Street Commissioner be instructed to notify all the Railroad Companies crossing New Jersey street, on the north side of Pogue Run, to enlarge the culvert running under their tracks on the west side, so as to permit the water running down said street to pass into Pogue Run without any obstruction. And that he be further notified to cause the culvert on the east side of said street to be properly cleaned out.

Which was adopted.

Mr. Cottrell, also, offered the following motion :

That the Street Commissioner proceed at once to improve Delaware street, in compliance with an ordinance for the improvement of said street; and that he be further directed to have the gutter on the east side of said street opened in such a manner as to drain the water from South to Bicking streets.

Which was adopted.

Also, the following motion :

That John Gates be permitted to bowlder the sidewalk in front of his blacksmith shop on New Jersey street, between Washington street and Pogue Run, under the direction of the Civil Engineer.

Which was adopted.

Mr. Davis, from the Board of Public Improvements, made the following report :

OFFICE BOARD OF PUBLIC IMPROVEMENTS, }
Indianapolis, Sept. 14, 1868. }

To the Mayor and Common Council of the City of Indianapolis :

GENTLEMEN:—The Board of Public Improvements, to whom was referred the various matters, would report :

1st. That D. Root & Co. are the only bidders for the erection of lamp-posts, lamps and fixtures on California street, between Vermont and Michigan streets, and on Meridian street, or Bluff Road, between Ray and Morris streets, their bid being for the corner posts \$36, and for the intermediate posts \$34. We recommend that the contract be awarded to said parties for the erection of said posts.

2d. The Board have examined the petition of Ninevah White, asking for the privilege of erecting a frame office on the corner of Market and Delaware streets, and recommend that the prayer of the petitioner be not granted, as it is inside of the fire limits.

3d. We recommend that the petition of Henry Hoffmeyer et al., asking for the improvement of Lockerbie street, between Noble and Liberty streets, be not granted, for reasons stated before, that the property holders are not able to pay for said improvement.

4th A report of the Street Commissioner was referred to the Board recommending that certain culverts be built on Massachusetts Avenue; we recommend that no more bridges be built as the appropriation is exhausted.

INDIANAPOLIS, Sept. 14, 1868.

To the Mayor and Common Council of the City of Indianapolis :

The undersigned, owners of lots on Fayette street between North and St. Clair streets, to the amount of feet opposite our respective names, hereby protest against the grading and graveling of the same, as petitioned for by a minority of the lot owners on same street. We represent a majority of the number of feet on said street, being 845 feet. The total number of feet covered by said improvement is 1,649. Only 773 feet is represented in the petition for improvement—825 feet being necessary to constitute a majority.

Your petitioners further protest against the action of the Common Council in the passage of an ordinance authorizing said improvement without giving legal notice of the pendency of such an ordinance, and the passage of said ordinance under cover of a notice published more than a year ago, since which time much of the property has changed owners, and before any petition for said improvement, we regard as an attempt to deprive citizens of their right of remonstrance.
