Dear Sir:

Captain Martin J. Logan, who is claim agent for the Department of Law, is occupied a good share of the time in traveling over the city making investigation of claims and law suits against the city. Captain Logan is very much handicapped in this work because of the lack of proper transportation facilities, and I feel that an automobile should be provided for use of this department in conducting that work and also for use by the various members of the legal staff in the trial of cases claiming damages for accidents caused by defects in the city streets, which cases have been venued from the Marion County courts to courts in adjoining counties. We have a number of such cases pending almost all of the time and, due to the lack of adequate transportation facilities, it is quite a problem to get our witnesses to those courts to testify at such trials. The only city owned automobile that is ever at the disposal of this department is an old Buick, which cannot be depended upon to make such trips and which also is often in use for other purposes at times when it is most imperative that we have immediate use of a dependable automobile for the prompt transportation of attorneys and witnesses to out of town courts.

To meet these various needs, I am requesting the appropriation, by ordinance of the common council, of \$450.00 from the unexpended and unappropriated 1936 balance of the general fund to Department of Law Fund No. 72—Equipment, for the purchase of an automobile. If this request meets with your approval, I should be pleased to have you recommend such appropriation.

interested in Civic affairs, I believe you will be interested in this survey.

This survey goes into great detail in our attempt to get actual facts and data with which we are able to attack our many problems in fighting crime. Since I have held the office of Chief of Police I have tried continually to eliminate the guess-work in police work by conducting such detailed surveys, by modernization and by training of men.

This survey takes into consideration a great number of crimes, a total of 10,053, occuring over a long period of time, therefore, it gives us actual average facts, charts and tables contained therein show us WHEN to expect the peaks of different types of crimes, accidents, etc., it shows WHERE we can expect it, and shows the variation between week days and week ends, along with many other facts. Each chart is fully discussed and is accomplished by a table of statistics.

I wish particularly to call your attention, besides the charts and data to the introduction on pages 2 and 5, with special notice to pages 4 and 5. Of course we immediately made many changes indicated in the findings of this survey. I will appreciate receiving your comment on this survey.

18 feet on the south side of Maryland Street, starting at a point twenty-five (25) feet west of the west curb line of Capitol Avenue and extending west for a distance of eighteen (18) feet, said premises being occupied by Dunlap Tire and Rubber Company.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

SPECIAL ORDINANCE NO. 4, 1937

Beginning at the southeast corner of Lot No. 5 in the aforesaid John H.
