We, the Special Committee consisting of Mr. Kealing, Mr. Oren and Mr. Schumacher, to which was referred Resolution No. 3, 1937, make the following report:

Mr. Kealing filed 14 copies of Resolution No. 3, 1937, just a few minutes before 12:00 noon with the City Clerk on May 3, 1937.

Referring to Rule 5 of Rules and Regulations governing the Common Council of the City of Indianapolis;

No ordinance shall be introduced at any regular meeting unless 14 copies of the same have been in the hands of the City Clerk at least at noon of the day on which such regular meeting is held.

This Special Committee wrote a letter to the Board of Safety on December 18, 1936, requesting that the names and politics of every person on the Police and Fire Departments of the City of Indianapolis be sent them as soon as possible.

During all these months the lists were not sent us so at the last possible filing date on May 3, 1937, Resolution No. 3, 1937, was filed with the City Clerk. But lo and behold, that evening at Council meeting two lists were presented to the Council.

We again state, that according to the merit law, there should be an equal number of Republicans and Democratic policemen and firemen. The Police list given us May 3, 1937, shows Republicans 250 and Democrats 261. Now, why is it that in the present Police Merit School there are over 60 Democrats and no Republicans, of whom 12 Democrats will have to be selected? It looks as if this so called Merit System is a Merit System for Democrats only.

Now after so many months we have finally received these lists, The Special Committee to whom was referred Resolution No. 3, 1937, beg leave to report that we have had said Resolution under consideration, and recommend that the same be stricken from the files.

APPROPRIATION ORDINANCE NO. 22, 1937

AN ORDINANCE accepting and appropriating the proceeds received from President Roosevelt's 55th Anniversary Balls held in Indianapolis, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Eight Hundred Twenty-nine Dollars and Sixty-six Cents (\$829.66), offered and given to the City of Indianapolis as a part of the proceeds received from President Roosevelt's 55th Anniversary Balls held in Indianapolis, is hereby accepted by said city from the President's Birthday Ball Committee in accordance with the agreement made with such committee.

Section 2. That the particular sum and fund of Eight Hundred Twenty-nine Dollars and Sixty-six Cents (\$829.66), as set out in Section 1 of this Ordinance, is hereby made a part of the Tuberculosis Prevention Fund of the Department of Health and Charities and appropriated and allocated to the following established fund as per 1937 budget classification:

BOARD OF HEALTH ADMINISTRATION TUBERCULOSIS PREVENTION

Fund No. 26-Other Contractual 261 Infantile Paralysis \$829.66

Section 3. This ordinance shall be in effect after its passage and approval by the Mayor.

APPROPRIATION ORDINANCE NO. 23, 1937

AN ORDINANCE appropriating Eighteen Hundred Dollars (\$1800.00) from the unexpended and unappropriated 1936 balance of the general fund to a certain fund of the Department of Public Safety, and fixing a time when the same shall take effect

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Eighteen Hundred Dollars (\$1800.00) is hereby appropriated from the unexpended and unappropriated 1936 balance of the general fund of said city to the Department of Public Safety for use in completing the erection of the new dog pound, and said sum so appropriated is hereby allocated to the following designated fund of said department, hereby etablished:

BOARD OF PUELIC SAFETY ADMINISTRATION

Section 2. This ordinance shall be in effect after its passage and approval by the mayor.

INTRODUCTION OF GENERAL ORDINANCES

By the Board of Safety:

GENERAL ORDINANCE NO. 30, 1937

AN ORDINANCE providing for the registration of bicycles and the issuance of certificates of title therefor, the transfer of ownership of bicycles, the selling and painting of bicycles and parts thereof, prohibiting the mutilating or removing of registration numbers thereof, requiring presentation of certificates of title to the City Controller before issuance of bicycle licenses or making a transfer of such license, prescribing a penalty for violations thereof, and fixing a time when the same shall take efffect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. Thirty (30) days after the taking effect of this ordinance, it shall be unlawful for any person to ride or propel upon any public street, highway, boulevard, or other public place in the

City of Indianapolis, any bicycle unless such bicycle has been registered by the owner therof with the Chief of Police of said city and a certificate of title issued therefor as in this ordinance provided for, and shall have displayed thereon the registration die-stamped tags provided for herein.

Section 2. Before any certificate of title shall be issued to the owner of any such bicycle, the owner thereof shall make application for the registration of such bicycle to the Chief of Police and for the issuance of a certificate of title for such bicycle by said Chief of Police. Said application shall be made upon a blank form to be furnished and prescribed by the Chief of Police and shall be acknowledged by a notary public or other officer empowered to administer oaths, and shall contain a full description of the bicycle, together with a statement of the applicant's title, and of any liens or encumbrances upon said bicycle. Said application shall contain the manufacturer's number on such bicycle, or, in the event no manufacturer's number is stamped thereon or has become mutilated or obliterated, the number assigned such bicycle and die-stamped thereon by the Chief of Police. Any such bicycle which has no manufacturer's number stamped thereon or on which the manufacturer's number has been mutilated or obliterated, shall be assigned a number by the Chief of Police which is identical with the number of the certificate of title issued for said bicycle, and such assigned number shall be die-stamped on such bicycle under the direction of the Chief of Police.

Section 3. Upon registration of any bicycle, the owner thereof shall be issued a numbered certificate of title showing the registration of such bicycle, and the owner shall receive from the Chief of Police a metal tag upon which the number of the certificate of title so issued shall be die-stamped. Said tag shall be securely attached to the front frame post of such bicycle so registered. The owner of any such registered bicycle shall preserve such certificate of title so issued, and, to establish title to such bicycle, present same upon demand of any police officer of the City of Indianapolis. Said certificate of title shall be good for the life of such bicycle so long as the same is owned or held by the original holder of such certificate, and shall not have to be renewed annually or at any other time. A duplicate of said registration certificate so issued shall be kept by the Chief of Police.

Section 4. On one side of the certificate of title issued to the owner of any such bicycle there shall be a form for the assignment or sale of the bicycle described on the opposite side of said certificate of title.

Section 5. Any person owning a registered bicycle and desiring to sell, trade or otherwise dispose of said bicycle, shall immediately fill out the assignment on the reverse side of the certificate of registration of said bicycle and shall deliver the certificate of registration to the purchaser or recipient of said bicycle: said purchaser or recipient of the bicycle shall then turn said certificate in to the Chief of Police of said City of Indianapolis and re-register said bicycle in his name within three (3) days of the purchase or receipt of said bicycle.

Section 6. Hereafter no license for any bicycle shall be issued to any person, or any transfer of a bicycle license be made to any person, by the City Controller, except upon presentation to the City Controller by such person of a certificate of title showing such person to be the owner of the bicycle for which a license, or transfer thereof, is desired.

Section 7. No provision in this ordinance shall in any wise affect the provisions of any other ordinance concerning bicycle licenses. except as provided in Section 6.

Section 8. No person shall alter, remove, deface or mutilate the manufacturer's number or the number die-stamped thereon under the direction of the Chief of Police, or his identification tag, or the certificate of title, of any bicycle so registered.

Section 9. No person shall repaint any bicycle or repaint or remove the name plate, identification tag or parts from any bicycle, or sell or pawn or attempt to sell or pawn any bicycle or parts thereof, when such person is not the owner thereof, without the consent of the owner.

Section 10. Any owner of a registered bicycle having the same stolen shall report the theft of said bicycle to the Police Department of the City of Indianapolis, Indiana, and report to said department when and after said bicycle is recovered or restored to said owner.

Section 11. If any bicycle is found in any street, or alley of the city without an identification tag, or with a mutilated frame number, it shall be prima facie evidence that said bicycle is being operated on the streets of the city without having been registered. Said bicycle shall immediately be impounded and shall only be surrendered to the owner thereof upon proof of ownership satisfactory to the Chief of Police. At the expiration of six (6) months after such impounding, each bicycle which has not been claimed shall be sold at public auction. Notice containing the description of the bicycle, or bicycles, to be sold shall be published in a newspaper of general circulation in the City of Indianapolis at least once each week for two (2) weeks prior to such sale.

Section 12. The registration of bicycles shall be under the supervision of the Chief of Police of the City of Indianapolis, Indiana. No fee shall be charged for the initial registration, but for any replacement of any certificate or identification tag a fee of twenty-five cents (25c) shall be charged the owner thereof.

Section 13. Any matters required to be performed herein by the Chief of Police, or before or with the Chief of Police, may be performed by, or before, or with any member of the police force designated and chosen by the Chief of Police to attend to such duties.

Section 14. Any person violating any provision of this ordinance shall be fined in any sum not to exceed One Hundred Dollars (\$100.00), to which may be added imprisonment for a period not exceeding ninety (90) days.

Section 15. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

GENERAL ORDINANCE NO. 31, 1937

AN ORDINANCE to license bicycles and to regulate the riding and operation of the same, providing a penalty, repealing all ordinances in conflict therewith, and particularly repealing General Ordinance No. 47, 1934, and sub-section 34 of section 476 of General Ordinance No. 121, 1925, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. No person shall ride or propel a bicycle upon any public highway, street, boulevard, or other public place in the City of Indianapolis, unless the same shall be licensed as herein provided.

Section 2. Licenses for bicycles shall be issued by the City Controller and shall be issued for the remainder of the calendar year in which they are issued. The license fee for any such license shall be fifty cents (50c). In addition to the prescribed license fee, there

shall be paid to such Controller, by the applicant for a bicycle license, a fee of one dollar (\$1.00) for issuing such license. Bicycle licenses shall not be transferable.

- Section 3. Conditions of License: Every license issued hereunder shall be deemed to be granted subject to the following conditions:
 - (a) No person shall ride or propel any bicycle upon any sidewalk in such a manner as to interfere with any pedestrian thereon
 - (b) No person shall ride or propel a bicycle upon any public street, highway or sidewalk except in a prudent and careful manner, and unless such person shall be capable of efficient control and operation of such bicycle; nor shall any person propelling or operating a bicycle upon a public street, highway or sidewalk, carry, or permit to be carried, any other person upon such bicycle.
 - (c) No bicycle shall be ridden faster than is reasonable and proper, but every bicycle shall be operated with reasonable regard to the safety of the operator and other persons upon the streets and other public highways of the city.
- (d) Persons riding bicycles shall observe all traffic signs and stop at all stop signs.
 - (e) No bicycle shall be permitted on any street or other public highway of the city between thirty minutes after sunset and thirty minutes before sunrise, without a headlight visible from the front thereof for not less than 200 feet indicating the approach or presence of the bicycle, firmly attached to such bicycle and properly lighted, nor without a red tail light or in lieu thereof a reflector attached to and visible from the rear of such bicycle for a distance of not less than 200 feet. No person under the age of sixteen (16) years shall ride or propel a bicycle upon any street, highway or sidewalk at night after the hour of 9:00 o'clock P. M.
 - (f) No person shall ride or propel a bicycle upon any public street, highway or sidewalk in the city abreast or to the left of any other person so riding or propelling a bicycle.
 - (g) Every person riding or propelling a bicycle upon any public street, highway or sidewalk in the City of Indianapolis shall observe all traffic rules and regulations applicable thereto, and, shall turn only at intersections, signal for all turns, ride

at the righthand side of the street or highway, pass to the left when passing overtaken vehicles that are slower moving and shall pass to the right when meeting.

Section 4. Any person violating any of the provisions of this ordinance shall, upon conviction, be fined in any sum not exceeding One Hundred Dollars (\$100.00).

Section 5. All ordinances and parts of ordinances in conflict herewith are hereby repealed, particularly General Ordinance No. 47, 1934, and sub-section 34 of section 476 of General Ordinance No. 121, 1925.

Section 6. This ordinance shall be in effect after its passage, approval by the Mayor and publication according to law.

GENERAL ORDINANCE NO. 32, 1937

AN ORDINANCE abolishing the position of Assistant Market Master and transferring Seven Hundred Twenty-six Dollars and Sixty-seven Cents (\$726.67) from the fund appropriated for such position to certain other designated funds; changing the position of Market Master to Superintendent of the City Market; amending the budget of the Department of Public Safety—Market and Refrigeration, and repealing all parts of General Ordinance No. 60, 1936 (1937 budget) in conflict herewith; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the position of Assistant Market Master of the City Market under the Department of Public Safety is hereby abolished, effective June 11, 1937.

Section 2. Effective June 11, 1937, the position of Market Master of the City Market under the Department of Public Safety is hereby abolished.

Section 3. Effective June 11, 1937, there is hereby created the position of Superintendent of the City Market under the Department of Public Safety.

Section 4. Effective June 11, 1937, there is hereby added one additional janitor to the present force of four (4) janitors at the City Market.

Section 5. That Item 1, Services, Personal, of the 1937 budget of the Department of Public Safety—Market and Refrigeration, be amended as to positions and designated funds thereunder, effective June 11, 1937, as follows:

Section 6. Effective June 11, 1937, the unexpended balance of the sum heretofore appropriated by General Ordinance No. 60, 1936 (1937 budget) to Fund No. 11—Salaries and Wages, Regular, Market Master, in the Department of Public Safety—Market and Refrigeration, is hereby transferred therefrom and reappropriated to Fund No. 11—Salaries and Wages, Regular, Superintendent of the City Market, in the Department of Public Safety—Market and Refrigeration (as designated in Section 5 of this ordinance).

Section 7. GENERAL ORDINANCE NO. 33, 1937

AN ORDINANCE concerning the salaries, wages and compensation of officers and members of the Indianapolis Police Department, Police Radio Department, Indianapolis Fire Department and Gamewell Department, Indianapolis, Indiana, supplementing, suspending and repealing any and all general, special and appropriation Ordinances heretofore enacted and in conflict herewith; also of any Ordinances of the City of Indianapolis, Indiana, or any executive order heretofore made by any Board, Commission, Department or governing body of any department or official of said City; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA, That:

Section 1.
