COMMUNICATIONS FROM THE MAYOR

June 11, 1937.

To the Honorable President and Members of the Common Council of the City of Indianapolis, Indiana.

Gentlemen:

APPROPRIATION ORDINANCE NO. 22, 1937

AN ORDINANCE accepting and appropriating the proceeds received from President Roosevelt's 55th Anniversary Balls held in Indianapolis, and fixing a time when the same shall take effect.

APPROPRIATION ORDINANCE NO. 23, 1937

AN ORDINANCE appropriating Eighteen Hundred Dollars (\$1800.00) from the unexpended and unappropriated 1936 balance of the general fund to a certain fund of the Department of Public Safety, and fixing a time when the same shall take effect.

GENERAL ORDINANCE NO. 29, 1937

AN ORDINANCE authorizing the Board of Public Works and Sanitation to purchase, through its duly authorized purchasing agent, certain trucks and truck chassis, and fixing a time when the same shall take effect.

GENERAL ORDINANCE NO. 30, 1937

AN ORDINANCE providing for the registration of bicycles and the issuance of certificates of title therefor, the transfer of ownership of bicycles, the selling and painting of bicycles and parts thereof, prohibiting the mutilating or removing of registration numbers thereof, requiring presentation of certificates of title to the City Controller before issuance of bicycle licenses or making a transfer of such license, prescribing a penalty for violations thereof, and fixing a time when the same shall take effect.

GENERAL ORDINANCE NO. 32, 1937

AN ORDINANCE abolishing the position of Assistant Market Master and transferring Seven Hundred Twenty-six Dollars and Sixty-seven cents (\$726.67) from the fund appropriated for such position to certain other designated Funds, changing the position of Market Master to Superintendent of the City Market; amending the budget of the Department of Public Safety—Market and Refrigeration, and repealing all parts of General Ordinance No. 60, 1936 (1937 budget) in conflict herewith; and fixing a time when the same shall take effect.

To the Honorable President and Members of the Common Council of the City of Indianapolis.

Gentlemen:

I am returning to you herewith General Ordinance No. 33, without my signature.

I am doing this because I have been advised by the Corporation Counsel of the City of Indianapolis and the Attorney General of the

State of Indiana that this Ordinance is illegal, and that it violates certain laws of the State of Indiana which protect the fiscal integrity

and financial credit of cities in Indiana. These laws are identified as Chapter 233, Acts 1933, and Chapter 150, Acts 1935. The principles set out in these Acts are that the salaries fixed in the annual budget shall not be increased during the ensuing calendar year, and that except in cases of casualty, accident or extraordinary emergency, budgets as adopted by the Common Council for the year shall limit the expenditures for that year.

May I not suggest that you consider the matter involved in General Ordinance No. 33, to-wit: the restoration of salaries to the firemen and policemen of the City of Indianapolis, at the time when something may be accomplished along this line which will be legal and valid; that is, when the budget for the next calendar year is made up by your honorable body.

May I also suggest that you consider the claims of other employees of the City of Indianapolis to at least partial restoration of salary cuts made as to them during the period of the recent depression, with particular reference to the low wage scale groups employed at the City Hospital, Park Department, Sewer Department, and Street Commissioner's Department.

Because of my personal friendship for each individual member of the Council, I feel an obligation to convey to you the following quotation contained in the opinion recently given to me by the Honorable Omer Stokes Jackson, Attorney General of the State of Indiana:

"Your attention is further directed to a provision of the Act above quoted which makes any officer or officers of any municipal corporation, having authority to make appropriations for the expenditure of public money, guilty of malfeasance in office if they appropriate any money for any item set forth in the published budget in excess of the amount estimated to be expended, without having first given notice to the taxpayers and without certifying thir determination to make additional appropriations to the state board of tax commissioners. The penalty is the amount of such excess so appropriated, together with costs and attorneys fees plus twenty-five per cent of such amount."

AN ORDINANCE amending Section 7 of General Ordinance No. 87, 1935, and fixing a time when the same shall take effect

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Section Seven (7) of General Ordinance No. 87, 1935, be amended to read as follows: :

Section 7. Every vehicle licensed under the provisions of this ordinance shall bear the name or names of the owner or owners thereof, in letters at least two (2) inches in height plainly printed on a door on each side of said vehicle, and there shall be printed thereon, following such name, the word "owner" or "owners." Each such vehicle shall also bear thereon on such doors, plainly printed in letters at least two (2) inches in height, the name or names of the licensee or licensees thereof. Each such vehicle shall likewise have the number of the taxicab assigned by the City Controller, in letters at least four (4) inches in height, on each side of said vehicle, and likewise, on the rear of such vehicle, immediately above or below the rear window of said vehicle. No names other than the names provided for in this section and no taxicab number other than the taxicab number assigned by the City Controller shall appear on any taxicab or vehicle operating under the provisions of this ordinance, nor shall any vehicle licensed under this ordinance operate in the city without the current license certificate affixed in a prominent position therein.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

Mrs. Dowd presented the following written motion to amend General Ordinance No. 31, 1937:

MOTION TO AMEND

June 21, 1937.

Mr. President:

I move that Section 2 of General Ordinance No. 31, 1937, be amended to read as follows:

Section 2. Licenses for bicycles shall be issued by the City Controller and shall be issued for the remainder of the calendar year in which they are issued. The license fee for any such license shall be twenty-five cents (25c). In addition to the prescribed licensee fee there shall be paid to such controller by the applicant for a bicycle license, a fee of One Dollar (\$1.00) for issuing such license. For every bicycle licensed the City Controller shall issue a metal plate or tag of a size suitable for attaching to the rear portion of the saddle or to the rear fork of such bicycle. Said plate or tag shall bear the number of the license issued for such bicycle and the year for which the same is issued, and shall indicate thereon that the same is a bicycle license by bearing the word "bicycle" or the letter "B." The licensee shall place and keep such plate or tag on the rear fork of the bicycle licensed in a clearly visible location during the life of the license. In the event that any such tag or plate so issued shall be lost or stolen, the City Controller, upon the filing of an affidavit showing such fact. shall issue a duplicate plate or tag to the person entitled to the same. A fee of twenty-five cnts (25c) shall be charged by the City Controller for any such duplicate plate or tag so issued.

Whenever the ownership of any bicycle licensed under this ordinance shall have been assigned or sold, and there shall have been delivered to the purchaser or assignee the original license issued by the controller for such bicycle and there shall have been a compliance with Section 5 of General Ordinance No. 30, 1937, such assignment, delivery and compliance, upon presentation to the Chief of Police of such original license, shall operate as a transfer to the assignee or purchaser of the license issued for such bicycle. At the time of the issuance of a certificate of title by the Chief of Police to such assignee or purchaser, in accordance with such Section 5 of such ordinance, and upon presentation of the original license, as aforesaid, the Chief of Police shall note on such certificate of title and such license that the license theretofore issued for such bicycle is transferred to the person in whose name such certificate is issued. No fee shall be charged for any such transfer of such bicycle license.
