GENERAL ORDINANCE No. 84, 1937

AN ORDINANCE to amend General Ordinance No. 114, 1922, commonly known as the Zoning Ordinance.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the U1 or Residence District, the A1 or 7500 sq. ft. area District and the H1 or 50 ft. Height District, as established by General Ordinance No. 114, 1922, be and the same are hereby amended, supplemented and extended so as to include the following described property:

Beginning at a point on the west property line of Central Avenue at its intersection with the center line of the first alley southeast of Riverview Drive, thence southwest and south along the center line of the first alley southeast and east of Riverview Drive and the production of said center line to the south property line of 64th Street, thence west along the south property line of 64th Street and the production of said south property line to the west property line of Washington Boulevard, thence south along the west property line of Washington Boulevard to the center line of the first alley southeast of Riverview Drive, thence southwest along the center line of the first alley southeast of Riverview Drive and the production of the said center line to the southwest property line of Delaware Street to the north property line of 63rd Street, thence west and northwest along the north property line of 63rd Street and the production of said north property line to the east line of White River, thence southwest and south following the meanderings of the east bank of White River to the center line of the Spring Mill Road, thence southeastwardly along the center line of the Spring Mill Road and the production of said center line to the east property line of Riverview Drive, thence north along the east property line of Riverview Drive to the south line of 61st Street, thence east along the south line of 61st Street to the west line of the Indiana Central Canal, thence northeastwardly following the west line of the Indiana Central Canal to the west property line of Central Avenue, thence north and northwest along the west property line of Central Avenue to the point or place of beginning.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.

MISCELLANEOUS BUSINESS FILING OF PETITIONS

Petitions bearing the signature of more than fifty (50) persons purporting to own taxable real estate in the City of Indianapolis were filed, which petitions requested the Common Council to cause to be issued bonds of the City of Indianapolis in a total sum not exceeding one hundred ten thousand dollars (\$110,000.00) for the purpose of obtaining funds with which to complete the construction and equipment of the new building now in the course of construction and equipment at the Indianapolis City Hospital, known as the F-Wing of said hospital, and to pay other costs in connection therewith. Said petitions were verified by more than one of the signers thereof and there was attached to said petitions a certificate of the Auditor of Marion County, Indiana, to the effect that all such petitioners are owners of taxable real estate in the City of Indianapolis.

Said petitions, omitting the signatures thereon, were in the following words and figures:

"PETITION REQUESTING THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS TO CAUSE TO BE ISSUED CERTAIN BONDS OF THE CITY OF INDIANAPOLIS

"To the President and Members of the Common Council of the City of Indianapolis, Indiana:

"The undersigned, owners of taxable real estate in the City of Indianapolis, do petition the Common Council of said city to cause to be issued bonds of the City of Indianapolis in a total sum of not more than One Hundred Ten Thousand Dollars (\$110,000.00) for the purpose of obtaining funds with which to complete the construction and equipment of the new building now in the course of construction and equipment at the Indianapolis City Hospital, which building is known as the F-Wing of said hospital, and to pay architect's fees for supervising the completion of said building and to pay for the razing of certain old building and the improvement of the ground adjacent to said F-Wing building."

The form of the verifications on said petitions was as follows:

"....., being duly sworn, says that he is the owner of taxable real estate in the City of Indianapolis; that he signed the foregoing petition; that the other signatures appearing on the foregoing petition are the true and genuine signatures of persons whose names appear in writing thereon.

Indianapolis, Ind., October 18, 1937.

Mr. President:

I move that General Ordinance No. 52, 1937, be amended to read as follows:

- AN ORDINANCE regulating the practice of barbering within the City of Indianapolis.
- WHEREAS, the General Assembly of the State of Indiana has enacted a statute creating a State Board of Barber Examiners and regulating the practice of barbering including sanitary regulations in the interest of the public health, safety and general welfare, and
- WHEREAS, unrestricted closing hours for barbering establishment makes more difficult efficient supervision and inspection of such places and contributes to unhealthful, unjust and demoralizing standards of service; NOW THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That all persons engaged in the practice of barbering, as now defined by the statutes of the State of Indiana, shall be subject to the following provisions and regulations of this ordinance. Provided, that all persons registered under the 1925 Act of the Indiana General Assembly regulating the practice of beauty culture and all persons having a hair cutter's certificate, issued by the State Board of Barber Examiners, shall be exempt from the provisions of this ordinance.

Section 2. It shall be unlawful for any person, firm or corporation to engage in the practice of barbering for hire or to operate or permit barbering to be practiced in any barber shop or other place where barbering is practiced, earlier than 7:00 o'clock A. M. nor later than 7:30 P. M. on any days except those immediately preceding Sundays and the following holidays, to-wit: New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day and Christmas, on which days such places may remain open for business not later than 9:00 o'clock P. M. provided nothing herein shall prevent anyone engaged in barbering from serving customers after such closing hours who entered the barber shop previous thereto and who remain in the shop until served. Section 3. Barber shops shall remain entirely closed on all Sundays and on the following holidays, to-wit: New Year's Day, Fourth of July, Labor Day, Thanksgiving Day and Christmas.

Section 4. Any person, firm or corporation found guilty of violating any of the provisions of this ordinance shall be fined not less than Ten (\$10.00) Dollars nor more than One Hundred (\$100.00) Dollars, and each day such violation continues shall be considered a separate offense.

Section 5. If any section or part of this ordinance shall be declared by the court invalid, the same shall not be construed to affect any other portion thereof, but all such other portions shall remain in full force and effect.

Section 6. This ordinance shall be effective from and after its passage, approval by the mayor and publication according to law.
