- WHEREAS, on the 15th day of October, 1937, the Board of Health of the City of Indianapolis adopted the following resolution:
  - "WHEREAS, there is not now and will not be sufficient funds at the disposal of the Board of Health of the City of Indianapolis with which to complete the construction and equipment of the new building now in the course of construction and equipment at the Indianapolis City Hospital, which building is known as the F-Wing of said hospital, and to pay architect's fees for supervising the completion of said building, and to pay for the razing of certain old buildings and the improvement of the ground adjacent to said F-Wing building; and
  - "WHEREAS, the approximate cost of accomplishing said above purposes will be One Hundred Ten Thousand Dollars (\$110,000); NOW, THEREFORE,

On final adoption of this ordinance, the City Clerk shall immediately cause to be published and posted, in the manner required by law, a notice of the determination of the city to issue all of the bonds authorized by this ordinance and to incur the debt evidenced thereby. Said bonds shall be offered for sale by the Acting City Controller as soon as may be done after the passage of this ordinance and the expiration of the time provided by law in which remonstrances may be filed by the owners of taxable real estate with said Common Council praying that the bonds herein authorized be not issued. Prior to the sale of any of said bonds the Acting City Controller shall cause to be published a notice of the sale of said bonds, once each week for two weeks in two (2) local newspapers. The date fixed for the sale of said bonds shall be not earlier than seven days after the last of said publications. Said bond sale notice shall state the time and place of sale, the purpose for which the bonds are issued, the amount thereof, the maximum rate of interest thereon, the time of payment, and the terms and conditions upon which bids will be received and the sale made, and such other information as the Acting City Controller shall deem necessary.
