PROPOSAL NO. 202, 1975. Councilman West read the Proposal and Councilman Griffith moved, seconded by Councilman Kimbell that Proposal No. 202, 1975, in the revised version be adopted. Proposal No. 202, 1975, as revised, was retitled Special Resolution No. 5, 1975, and reads as follows:

CITY-COUNTY SPECIAL RESOLUTION NO. 5, 1975

A SPECIAL RESOLUTION authorizing the extension of certain

housing programs of the Community Services Program until June 30, 1975, under provisions for interim funding from a federal grant.

- WHEREAS, City-County Fiscal Ordinance No. 82, 1972 (Proposal No. 448, 1972) authorized the application and approved the appropriations for a certain action Year 3 amendment to the Comprehensive Year Program as part of the Community Services Program, authorized under Title One of the Demonstration Cities and Metropolitan Development Act of 1966; and
- WHEREAS, one of the programs and appropriations thereby approved was for a not-for-profit housing construction and rehabilitation loan guarantee program sponsored by the Greater Indianapolis Housing Development Corporation in the sum of Seven hundred thirty-six thousand two hundred thirty-eight dollars (\$736,238.00) for the calendar year 1973; and
- WHEREAS, one of the programs and appropriations thereby approved was for a counseling program sponsored by the GIHDC for the calendar year 1973; and
- WHEREAS, the continued operation of said programs of housing construction, rehabilitation, loan guarantees and counseling was authorized for the calendar year 1974 with that of counseling under a separate contract; and
- WHEREAS, GIHDC was informed by the administrator of the Community Services Program that the projects were eligible for extension under interim funding until June 30, 1975; and
- WHEREAS, it was not possible to continue the programs in the manner originally contemplated since expenditure of the new funding will not be available until after completion of the Environmental Impact Study (approximately July 1, 1975) and such funds cannot be used retroactively; and
- WHEREAS, regulations of the federal government promulgated after such notice of extension indicated that the methods and procedures used in continuing procedures followed in extending said program may not have been completely in accord with the federal regulations; and

- WHEREAS, the City-County Council has authorized and approved the continuance of these programs under the Community Development Ordinance; and
- WHEREAS, the City-County Council now determines that there should not be a gap in such programs and that such programs should be authorized and continued until June 30, 1975; and
- WHEREAS, the extension of said program for such time does not involve the expenditure or allocation of any sum in excess of the amount originally approved by the City-County Fiscal Ordinance No. 82, 1972; now therefore:

BE IT RESOLVED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND MARION COUNTY, INDIANA:

Section 1. The Council does hereby extend and authorize the continuation of the "non-profit Housing Construction and Rehabilitation Loan Guarantee Program sponsored by GIHDC" in accordance with the original contract approved pursuant to 1975 and does hereby renew, extend and authorize the continuation of the counseling program sponsored by GIHDC in accordance with the original contract.

Section 2. The Community Services Division of the Department of Administration is hereby authorized to take appropriate action for the extension of said program and to assure that such programs and the administrative costs thereof are properly funded.

Section 3. This ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
