MINUTES OF THE CITY-COUNTY COUNCIL AND SPECIAL SERVICE DISTRICT COUNCILS OF INDIANAPOLIS, MARION COUNTY, INDIANA

REGULAR MEETINGS MONDAY, NOVEMBER 9, 1998

ADOPTION OF THE AGENDA

PRESENTATION OF PETITIONS, MEMORIALS, SPECIAL RESOLUTIONS, AND COUNCIL RESOLUTIONS

PROPOSAL NO. 698, 1998. The proposal, sponsored by Councillor Talley, recognizes the Indiana Athletic Teen Basketball Association. Councillor Talley read the proposal and presented representatives with a copy of the document and Council pins. Donna Williams, Executive

Director, thanked the Council for the recognition. Councillor Gray recognized Wayne Williams, a fellow firefighter, who also serves his community in this organization. Councillor Talley moved, seconded by Councillor Gray, for adoption. Proposal No. 698, 1998 was adopted by a unanimous voice vote.

WHEREAS, complementing the hardwood players is a corps of game announcers, trainers, coaches, concession workers, a Youth Advisory Council and even cheerleaders to help build enthusiasm; now, therefore:

BE IT RESOLVED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

SECTION 1. The Indianapolis City-County Council recognizes the Indiana Athletic Teen Basketball Association for their successful first year of existence, when more that 150 teenagers participated on ten teams.

Fourteenth Street, on the south side, from Meridian Street to Pennsylvania Street

SECTION 2. This ordinance shall be in full force and effect upon adoption and compliance with IC 36-3-4-14.

PROPOSAL NO. 658, 1998. The proposal, sponsored by Councillor Tilford, authorizes a weight restriction on 25th Street from Post Road to German Church Road (Districts 5, 12). By an 8-0 vote, the Committee reported the proposal to the Council with the recommendation that it do pass. Councillor Gilmer moved, seconded by Councillor Tilford, for adoption. Proposal No. 661, 1998 was retitled SPECIAL RESOLUTION NO. 47, 1998, and reads as follows:

CITY-COUNTY SPECIAL RESOLUTION NO. 47, 1998

A SPECIAL RESOLUTION requesting the Indiana Department of Transportation to add more lanes at the I-465 and Michigan Road interchange.

WHEREAS, the city of Indianapolis finds it necessary to promote the health, safety, and welfare of its citizens; and

WHEREAS, the city of Indianapolis desires to increase the efficient flow of traffic; and

WHEREAS, heavy congestion exists in the 86th Street and Michigan Road area; and

WHEREAS, southwest Hamilton County and southeast Boone County are experiencing enormous growth; and

WHEREAS, the I-465 and Michigan Road interchange is a primary access point to Indianapolis for both commercial and commuter traffic; and

WHEREAS, the I-465 and Michigan Road interchange is an essential route for emergency vehicles; and

WHEREAS, the I-465 and Michigan Road interchange suffers severe congestion that creates unsafe conditions; now, therefore:

BE IT RESOLVED BY THE CITY-COUNTY COUNCIL OF THE CITY OF INDIANAPOLIS AND OF MARION COUNTY, INDIANA:

SECTION 1. The Indianapolis City-County Council urges the Indiana Department of Transportation to reevaluate its current plans and add additional entrance and exit lanes on the ramps at the I-465 and Michigan Road interchange.

SECTION 2. The Mayor is invited to join in this resolution by affixing his signature hereto.

SECTION 3. This resolution shall be in full force and effect upon adoption and compliance with IC 36-3-4-14.

NEW BUSINESS

Councillor Golc stated that he has not received a response from the Parks Department to a letter he wrote in September asking several budget questions. The President asked Councillor Shambaugh, Chairman of the Parks and Recreation Committee, to follow up on a response from the Parks Department to Councillor Golc's letter. Councillor Shambaugh agreed to do so.

Councillor Coughenour stated that Council members should take the opportunity to view the restored gardens at Garfield Park.

Councillor Gilmer stated that Veteran's Day celebrations will take place downtown on Wednesday, November 11, 1998, beginning with a parade at 11:00 a.m. He stated that metered parking is free for the event, and encouraged Councillors to attend.

Councillor Bradford stated that every year he fries turkeys for the Council office, and that this year he, along with the support of Councillor Short, will be frying 200 turkeys on November 21, 1998 with the help of the Fraternal Order of Police (FOP), Indianapolis Fire Department, American Federation of State, County, and Municipal Employees (AFSCME), American Federation of Labor and Congress of Indiana Organization (AFLCIO), and Teamsters in order to raise \$20,000 to benefit "Sack Hunger." The turkeys will sell for \$100 apiece and he asked that if Council members would like to participate in this effort, he will provide a sign-up sheet and additional information in office mailboxes. The frying will take place at the FOP Headquarters on E. Washington Street from 6:00 a.m. to 12:00 noon.

Councillor Boyd recognized Dr. Dale H. Pole, professor in the School of Administration at Dow Holsey University in Halifax, Nova Scotia, researching government amalgamation.

ANNOUNCEMENTS AND ADJOURNMENT

The President said that the docketed agenda for this meeting of the Council having been completed, the Chair would entertain motions for adjournment.

Councillor Boyd stated that he had been asked to offer the following motion for adjournment by:

- (1) Councillor Tilford in memory of Reginald Clayton, Sr.; and
- (2) Councillors Tilford and O'Dell in memory of Raymond A. Young.

Councillor Boyd moved the adjournment of this meeting of the Indianapolis City-County Council in recognition of and respect for the life and contributions of Reginald Clayton, Sr. and Raymond A. Young. He respectfully asked the support of fellow Councillors. He further requested that the motion be made a part of the permanent records of this body and that a letter bearing the Council seal and the signature of the President be sent to the families advising of this action.

There being no further business, and upon motion duly made and seconded, the meeting adjourned at 7:49 p.m.
