POLICE FORCE BUDGET FOR 1976 "MAJORITY REPORT"

AN ORDINANCE creating the annual budget for the Police Special Service District of the City of Indianapolis, Indiana, for the fiscal year beginning January 1, 1976, and ending December 31, 1976, appropriating monies for the purpose of defraying the expenses and all outstanding claims and obligations of said Police District and the Police Pension Fund and fixing and establishing the annual rate of taxation and tax levy for the year 1976, for each fund for which a special tax levy is authorized and fixing a time when this ordinance shall take effect.

BE IT ORDAINED BY THE POLICE SPECIAL SERVICE DISTRICT COUNCIL OF THE CITY OF INDIANAPOLIS

Section 1. For the expenses of the Police Force of the City of Indianapolis for the fiscal year beginning January 1, 1976, and ending

December 31, 1976, the sums of money herein set out are hereby appropriated and ordered set apart out of the "Police Service District Fund: for the purposes herein specified, subject to the law governing the same:

Section 2. For the expenses and obligations of the Police Pensions of the City of Indianapolis, for the fiscal year beginning January 1, 1976, and ending December 31, 1976, the sums of money herein set out are hereby appropriated and ordered set apart out of the "Police Pension Fund" for the purposes herein specified, subject to the law governing the same:

Section 3. The salaries, wages and compensations of the various officers and employees of the Police District for the ensuring year are now approved by the Police Special Service District are hereby adopted and fixed and the respective amounts herein specified for personal services are hereby appropriated therefor; provided, however, that no person, official or employee whose salary or compensation has been approved as part of the Personal Services portion of this ordinance, or by any ordinance hereafter adopted, shall have any vested right to receive such amount, or any minimum amount, except as may be accured, or otherwise provided by statute. Control as to any decrease shall be vested in the body or executive having direction over the one affected, as provided by law.

Section 4. To defray the costs of government of the Police Special Service District in accordance with the appropriations stated in Sections 1 and 2 of this ordinance, certain anticipated and estimated revenues are allocated as follows:

(a) The "Police Service District Fund" for 1976 shall consist of all balances at the end of fiscal 1975 available for transfer into said fund, all miscellaneous revenues derived from sources connected with the operation of the Police Force, including traffic fines and intergovernmental reimbursements, those distributions of taxes allocated by state law on the basis of property taxes levied and assessed as this fund, and all amounts received by the levy of a rate of tax for this fund on all taxable property located in the Police Special Service District by virture of Section 5 of this ordinance, and those amounts appropriated from Revenue Sharing Trust Fund for priority expenditures of said service district.

(b) The "Police Pension Fund" for 1976 shall consist of all balances at the end of fiscal 1975 available for transfer into said fund, all miscellaneous revenues derived from sources connected with the operation of the Police Pension Fund, certain receipts from taxes on alcoholic beverages, those distributions of taxes allocated by state law on the basis of property taxes levied and assessed as this fund, those amounts appropriated from the Revenue Sharing Trust Fund for priority expenditures of said service district and all amounts received by the levy of a rate tax for this fund on all taxable property located in the Police Special Service District by virtue of Section 5 of this ordinance.

Section 5. That there is hereby levied and assessed or confirmed as may be required by law on all real estate and improvements and all business personal property of whatever description, tangible and intangible and choses in action of every kind and character in the Police Special District of the City of Indianapolis, as assessed and returned for taxation in said District for the year 1975, payable 1976, a tax rate of one dollar twenty-eight and three-tenths cents (\$1.283) for the Police Special Service District Fund on each one hundred dollars (\$100.00) valuation of such special service district taxable property, and twenty-one and eight-tenths cents (0.218) for Police Pension Fund on each one hundred dollars (\$100.00) valuation of such special service district taxable property.

Section 6. That the budget of said special service district shall be carried out with the revenues from taxation provided from the several tax

levies fixed in this Ordinance, and the miscellaneous receipts of said funds and with the use of portions or current balances, all as indicated on the following table:

Section 7. Section 1. City-County General Ordinance No. 129, 1975, is hereby approved.

Section 2. To the extent required by law, this action shall constitute concurrance with and adoption of City-County General Ordinance No. 129, 1975.

Section 3. This resoluton shall be in full force and effect from and after adoption.
