I move that General Ordinance No. 28, 1934 be amended to read as follows:

GENERAL ORDINANCE No. 28, 1934

AN ORDINANCE prohibiting the buying or selling and offering to buy or sell partially used non-transferable railroad tickets and providing a penalty for its violation.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY IF INDIANAPOLIS:

Section 1. That it shall be unlawful for any persons, association of persons, firm or corporation to buy or sell the unused portions of non-transferable railroad tickets whose use is restricted to the oiginal purchaser thereof by the railroad company issuing them, or to act as vendor or broker of partially used non-transferable railroad tickets or to solicit personally, or by sign or by advertisement or in any other manner to aid in the sale or

purchase of partially used non-transferable railroad tickets within the limits of the City of Indianapolis.

Section 2. Any person violating any of the provisions of this ordinance shall upon conviction thereof be punished by a fine in a sum not less than ten dollars nor more than twenty-five dollars, to which may be added imprisonment for not exceeding ten days or by both such fine and imprisonment, and each transaction relating to any one ticket shall be deemed a separate offense and shall be punishable accordingly.

Section 3. This ordinance shall take effect from and after its passage, approval by the mayor and publication as required by law.
