COMMUNICATIONS FROM CITY OFFICIALS

Gentlemen:

Attached you will find a copy of a letter from the Mayor of the City of Indianapolis, wherein he has determined that a contingency has arisen requiring the expenditure of a part of the appropriation in the Mayor's Contingency Fund, being Fund No. 26 of the Department of Finance, Office of the Controller, in the sum of \$250.00, to employ impartial experts to assist in the preparation of a new electric light and power contract with revised and appropriate specifications, for which purpose there was no available funds appropriated for such specific use.

I recommend that the sum of \$250.00 be set aside and made available out of said Mayor's Contingent Fund for the purposes aforesaid, to be paid by my warrants. I certify that said Fund contains more than sufficient money to pay said amount.

Dear Sir:

The city, through the board of public works, is required by statute to publish a notice at least once a year prior to the termination of the contract for the supply of electric light and power to the city inviting bids upon a new contract and to have ready proper specifications and form of such contract for submission to bidders. The present contract for that service expires May 1, 1935, and the required notices aforesaid have been duly given. In view of the necessity of making material revisions in the specifications for the new bids and contract and for the proper safeguarding of the public interests, it is necessary to obtain the assistance of impartial experts on such matters to cooperate with the city civil engineer and the board of public works and since there are no available funds appropriated for that specific purpose, I have determined that a contingency has arisen requiring the expenditure of a part of the appropriation reserved for contingencies in Fund No. 26 in the Department of Finance, Office of City Controller, and for that purpose I recommend the appropriation of \$250.00 for payment of all such services to such special experts who may be employed by the board of public works.

I hereby request that if the aforesaid funds are available in said contingent fund that you certify to such fact and approve such expenditures and notify the Common Council in writing thereof.

"In view of the judgment rendered by Judge Cox reinstating Mr. Harrison as a member of the department to his status as existing prior to September 12, 1933, "with all the rights accruing to him thereunder according to law," I am of the opinion that he should be paid his salary from the date of his suspension if not already paid. His accrued salary for 1934 may be paid out of the 1934 budget. In order to pay the salary accrued and unpaid for 1933, it may be necessary to have the council appropriate this amount."

The unpaid salary from September 12, 1933 to December 31, 1933 at \$1,789.09 per year, amounts to \$536.43. We respectfully submit for your consideration the matter of an appropriation ordinance to cover this amount.

INTRODUCTION OF APPROPRIATION ORDINANCES

APPROPRIATION ORDINANCE No. 23, 1934

AN ORDINANCE appropriating the sum of Five Hundred Thirtysix Dollars and Forty-six Cents (\$536.43) from the unappropriated and unexpended balance of the General Fund for the year 1933 and transferring the same to Department of Public Safety, Fire Department Fund No. 11—Salaries and Wages, Regular (Chauffeurs), and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS:

- SECTION 1. That there be and there is hereby appropriated out of the unappropriated and unexpended balance of the General Fund for the year 1933 the sum of Five Hundred Thirty-six Dollars and Forty-three Cents (\$536.43) and the same is hereby transferred to Department of Public Safety, Fire Department Fund No. 11—Salaries and Wages, Regular (Chauffeurs).
- SECTION 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

INTRODUCTION OF RESOLUTIONS.

WHEREAS, the City through the board of public works, is required by law to advertise for bids for a new electric light and power contract for the city not less than one year from the date of expiration of the current contract, which expires May 1, 1935, and accordingly said board has published notice asking for bids on a new contract, to be based on specifications revised and appropriate to present conditions for which it is deemed necessary by the Mayor and said board, in the interest of public welfare, to secure the advice and assistance of competent outside experts to examine and approve such specifications and contract; and

- WHEREAS, there are no funds available now appropriated for that purpose except in the Mayor's Contingent Fund and accordingly the Mayor has determined that such facts present a contingency requiring the expenditure of Two Hundred Fifty Dollars (\$250.00) out of the fund known as Mayor's Contingent Fund, No. 26 in the budget of the Department of Finance, Office of City Controller, for the employment and payment of such necessary experts not in the employ of the city; and
- WHEREAS, the City Coneroller has approved said proposed expenditure and notified the City Council in writing, giving all the pertinent facts pertaining to the contingency and the manner in which it is proposed to meet the same and certified that there are funds available in said fund for that purpose; and
- WHEREAS, the Common Council now determines that such contingency exists and that the use of the sum requested should be authorized for payment from the aforesaid fund and that such sum is now available for that purpose,

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

- SECTION 1. That the Common Council hereby approves and authorizes the expenditure, upon a warrant or warrants of the City Controller, at any time during the fiscal year ending December 31, 1934, the aggregate sum of Two Hundred Fifty Dollars (\$250.00) out of the aforesaid Fund No. 26, Department of Finance, Office of City Controller, for the purposes specified in the preamble hereof; such warrants to be issued upon requisition therefor signed by the board of public works and approved by the Mayor.
- SECTION 2. That this resolution shall become effective and said fund available for use from and after the passage thereof and its approval by the Mayor.

- SECTION 2. That the said ambulance chassis and the said ambulance body, which is to be mounted upon said chassis, shall be purchased from the lowest and best bidder or bidders after duly advertising for competitive bids thereon according to law. Provided, however, that the total price to be paid for said ambulance chassis and custom made ambulance body shall not exceed the sum of Twenty-seven Hundred Twenty-five Dollars (\$2,725.00).
- SECTION 3. That the net purchase price of said ambulance shall be paid out of funds heretofore appropriated to the Department of Public Health and Charities of the City of Indianapolis for the year 1934.
- SECTION 4. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
