1931, relative to the establishment of a passenger and/or loading zone, at the place hereinafter set out, and said board having caused an investigation to be made thereof and having recommended its establishment, pursuant to the terms of the aforesaid ordinances, the following passenger and/or loading zone be and the same is hereby established in the City of Indianapolis, to-wit:

> 18 feet in front of 3120 East Washington Street, said premises being occupied by Miller Oldsmobile Company.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

GENERAL ORDINANCE NO. 7, 1935

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

GENERAL ORDINANCE NO. 10, 1935

AN ORDINANCE transferring money from a certain fund, reappropriating and reallocating the same to another designated fund, and fixing a time when the same shall take effect.

Section 1. That transfer, reallocation and reappropriation of moneys within the budget of the Department of Public Safety, Police Department, be made as follows:

Five Thousand One Hundred Twelve Dollars (\$5,112.00) from the sum appropriated for the payment of Patrolmen, First Grade, under Item 1—Services, Personal, Fund 11—

Salaries and Wages, Regular, into the fund appropriated for the payment of Patrolmen, Second Grade, in said Item 1.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

GENERAL ORDINANCE NO. 11, 1935

AN ORDINANCE concerning the time of the delivery of milk, cream or other dairy products, in liquid form, for human consumption; providing a penalty and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. It is hereby declared that milk, cream and other dairy products are necessary and vital articles of human food and that the sale and distribution of milk, cream or other dairy products, in liquid form, for human consumption, free from contamination, is a business effecting the public health and welfare.

Section 2. That no person, firm, corporation or association shall make any delivery of any milk, cream or other dairy products, in liquid form, for human consumption, except to hospitals or other public or charitable institutions, between the hours of Four o'clock P. M. and Seven o'clock A. M., beginning September (16) Sixteenth and ending April (15) Fifteenth of each year; nor between the hours of Four o'clock P. M., and Two o'clock A. M. beginning April (16) Sixteenth and ending September (15) Fifteenth of each year.

Section 3. Any person, firm, corporation or association violating any of the provisions of this ordinance shall, upon conviction, be punished by a fine of not less than Five (\$5.00) Dollars nor more than Twenty-five (\$25.00) Dollars and costs.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law. Which was read the first time and referred to the Committee on Public Health and Charities.
