#### SPECIAL ORDINANCE NO. 1, 1935

AN ORDINANCE authorizing and approving the acceptance of a proposed supplemental and additional grant to be made by the United States of America to the City of Indianapolis for the purpose of constructing and equipping a public tuberculosis hospital and a dispensary for the sick poor of said city, approving the terms and conditions of said proposed grant, and fixing a time when this ordinance shall take effect.

#### APPROPRIATION ORDINANCE NO. 13, 1935

AN ORDINANCE appropriating moneys from the cash balance which the Board of Sanitary Commissioners had on hand in its Sanitary Maintenance and General Expense Fund on January 1st, 1935, and transferring said moneys so appropriated to certain funds and fixing the time when the same shall take effect.

#### APPROPRIATION ORDINANCE NO. 14, 1935

AN ORDINANCE re-appropriating the sum of seventeen dollars and fifteen cents (\$17.15) from the unappropriated and unexpended balance of 1934 in the Sanitary District Fund, transferring the same to a numbered fund for the purpose of paying an unpaid claim for the year 1934 and fixing the time when the same shall take effect.

# INTRODUCTION OF APPROPRIATION ORDINANCES

#### APPROPRIATION ORDINANCE NO. 19, 1935

- AN ORDINANCE creating and establishing in the Department of Public Safety, City Market budget, under Item 2—Services, Contractual, Fund 26—Other Contractual, and appropriating thereto the sum of Six Thousand Dollars (\$6,000), and appropriating also the sum of Two Thousand Dollars (\$2,000) to City Market budget Item 7—Properties, Fund 72—Equipment, both said sums being appropriated out of the unappropriated and unexpended balance of the general fund for the year 1934, and fixing a time when the same shall take effect.
- WHEREAS, the Board of Public Safety and the marketmaster of the City of Indianapolis are desirous and anxious to make certain improvements in the nature of a new restaurant section and other alterations to the city market and to dig a new deep well on said market premises; and
- WHEREAS, there is not now available in the budget of the city market sufficient funds with which to make such payments;

NOW, THEREFORE,

# BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That there be and there is hereby established in the Department of Public Safety City Market budget, under Item 2 —Services, Contractual, Fund 26—Other Contractual, and that the sum of Six Thousand Dollars (\$6,000) be and the same is hereby appropriated thereto out of the unappropriated and unexpended balance of the general fund for the year 1934.

Section 2. That the sum of Two Thousand Dollars (\$2,000) be and the same is hereby appropriated out of the unappropriated and unexpended balance of the general fund for the year 1934 and transferred to Department of Public Safety City Market budget, Item 7-Properties, Fund 72-Equipment.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.

## INTRODUCTION OF GENERAL ORDINANCES

By the Board of Safety:

### GENERAL ORDINANCE NO. 42, 1935

AN ORDINANCE amending Section 50 of General Ordinance No. 96, 1928, as amended, and declaring a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That Section 50 of Article VIII of General Ordinance No. 96, 1928, be amended to read as follows, to-wit:

"Section 50. USE OF TRAILERS RESTRICTED. It shall be unlawful for the registered owner, or for any one having the care and custody of any vehicle without motive power, commonly called a trailer, to park, or to suffer, permit or allow the same to stand or be parked on any public street or thoroughfare in the City of Indianapolis, unless the same be attached to another vehicle having motive power.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval by the Mayor and publication according to law.
