# INTRODUCTION OF GENERAL ORDINANCES

By Mr. Wallace:

# GENERAL ORDINANCE NO. 26, 1936

- AN ORDINANCE requiring the operators of motor vehicles and motor bicycles to give persons riding or leading a horse or horses the right of way at certain intersections of bridle paths and public streets, providing a penalty for the violation thereof, and fixing the time when the same shall take effect.
- WHEREAS, The Board of Park Commissioners of the City of Indianapolis have established bridle paths for the use of equestrians; and,
- WHEREAS, Said bridle paths, at certain points intersect and cross certain public streets, and the use of such bridle paths is being hampered and restricted because of the danger to equestrians riding through meter traffic at the intersections of said bridle paths and certain streets and boulevards hereinafter designated, thereby creating a traffic hazard; now, therefore,

# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. Every person driving or operating any motor vehicle or motor bicycle, shall yield the right of way to any person riding or leading a horse or horses from any bridle path in the City of Indianapolis, established by the Board of Park Commissioners of the City of Indianapolis, while said last named person is crossing or entering into or upon the hereinafter designated places and points, and said operator of such motor vehicle or motor bicycle shall, on signal by the raising of the hand and arm to a vertical position from any person riding or leading a horse or horses, bring his motor vehicle or motor bicycle to a stop not less than 15 feet from the point of intersection and/or crossing of such bridle path and the points and places hereinafter designated, and shall not proceed forward until such horse

or horses have cleared said crossing and/or intersection. The places and points to which this ordinance shall apply are as follows:

The intersection of 23rd Street and Harding Street;

The intersection of 23rd Street and East Riverside Drive:

The intersection of the Bridle Path and Burdsal Parkway;

The intersection of White River Parkway and the Bridle Path at 26th Street;

The intersection of 30th Street and the Bridle Path at the west and of the 30th Street bridge over White River;

The intersection of the Bridle Path, Cold Springs Road and 38th Street.

Section 2. It shall be unlawful for any person in control of or operating a motor vehicle or motor bicycle while stopped, pursuant to signal given as provided in Section 1 hereof, to race the motor of such motor vehicle or motor bicycle, or to blow or use any horn or sound warning device on any such vehicle in such manner as likely to frighten any horse.

Section 3. Provided that the provisions of this Ordinance shall not apply to any Police, Fire Department or other emergency motor vehicle or motor bicycle.

Section 4. Any person violating any of the provisions of this Ordinance shall, upon conviction, be punished by a fine in any sum not exceeding \$50.00.

Section 5. This Ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.
