duly appointed purchasing agent, to purchase four (4) Dump trucks and chassis for the Board of Works and Sanitation to use and be used in the operation and maintenance of streets, alleys and thoroughfares.

These bids were opened in public at 10:00 A. M. January 23rd, 1939 before the Board of Public Works and Sanitation after due advertisement therefor according to law, and a committee duly appointed consisting of Mr. Ernest Roepke, of the Finance Board of the City Council, Mr. Leo Welch of the Board of Public Works and Sanitation, Daniel G. Watkins, Superintendant of the Municipal Garage and Albert H. Losche, City Purchasing Agent.

All bidders were given an opportunity to speak on the merits of their individual trucks, and after due consideration, the committee decided and recommended that the Purchase be made from the International Harvester Company, on their Net Bid of \$4,510.72 for the four units, which was considered the lowest and best bid submitted for the purposes to which these trucks are to be assigned.

The City Purchasing Agent respectfully recommends the passage of this ordinance in order to facilitate the immediate purchase of this equipment for the Board of Works and Sanitation.

# INTRODUCTION OF APPROPRIATION ORDINANCES

## APPROPRIATION ORDINANCE No. 2, 1939

- AN ORDINANCE appropriating Fifteen Thousand Dollars (\$15,000) from the unappropriated and unexpended 1938 balance of the general fund of the Department of Health and Charities and allocating the same to certain designated funds of said department, and fixing a time when the same shall take effect.
- WHEREAS, the erection of an emergency smallpox pavilion is now under construction on and upon the grounds of the Indianapolis City Hospital, which said pavilion or barracks is being constructed in part by and through the aid of the Works Progress Administration of the Federal Government for the isolation and quarantining of active cases of smallpox; and
- WHEREAS, the completion of said smallpox pavilion or barracks is expected within a period of thirty (30) days, at which time said pavilion should be available for occupancy; and
- WHEREAS, the Department of Health and Charities desires to equip and maintain said emergency pavilion;

#### NOW, THEREFORE,

## BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. #### GENERAL ORDINANCE No. 4, 1939

AN ORDINANCE authorizing the Board of Public Works and Sanitation of the City of Indianapolis, through its duly authorized purchasing agent, to purchase four (4) dump trucks of one and one-half (1½) tons capacity, and fixing a time when the same shall take effect.

# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Board of Public Works and Sanitation, through its duly authorized purchasing agent, be and it is hereby authorized to receive bids, after duly advertising therefor according to law, and make purchase of four (4) dump trucks of one and onehalf  $(1\frac{1}{2})$  tons capacity, said dump trucks to be of either six (6) or eight (8) cylinders, steel dump bodies and hydraulic hoists.

Section 2. That said purchase shall be made from the lowest and best bidder, after advertising for competitive bids therefor, and the total combined cost of all said dump trucks shall not exceed the sum of Forty-five Hundred Ten Dollars and Seventy-two Cents (\$4510.72) and the allowance for the trade-in of the following, which trade-in is hereby authorized to be made at not less than the appraised value thereof as fixed by the Appraisal Board of said city viz: Four (4) dump trucks, city's numbers seventy (70), eightyone (81), one hundred forty-eight (148), and one hundred seventy (170).

Section 3. That the purchase of said equipment shall be paid out of the funds heretofore appropriated to the Board of Public Works and Sanitation.

Section 4. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

#### GENERAL ORDINANCE No. 5, 1939

AN ORDINANCE regulating the parking of vehicles upon the streets of the City of Indianapolis, providing a penalty for violation thereof, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CTTY OF INDIANAPOLIS, INDIANA:

Section 1. It shall be unlawful for the operator of any vehicle to park the same for a longer period than one and one-half hours between the hours of 7:00 A. M. and 6:00 P. M. on the following named streets, to-wit:

- (a) On both sides of Michigan Street, between Noble Street and Park Avenue.
- (b) On the north side of Michigan Street, between Park Avenue and East Street.

Section 2. Any person violating any provision of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00), to which may be added imprisonment not exceeding one hundred eighty (180) days.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.

#### GENERAL ORDINANCE No. 6, 1939

AN ORDINANCE prohibiting parking of vehicles upon certain streets of the City of Indianapolis, providing a penalty for the violation thereof, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. It shall be unlawful for the operator of any vehicle to park the same or suffer, permit or allow the same to be parked on the following streets:

- (a) On the south side of Raymond Street from the Pennsylvania Railroad right-of-way to Garfield Place, East Drive.
- (b) On the south side of Harrison Street from Shelby Street to Noble Street.

Section 2. Any person violating any provision of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00), to which may be added imprisonment not exceeding one hundred eighty (180) days.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the mayor and publication according to law.

# BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That for the purpose of providing the owners or occupants of certain premises fronting on certain public streets in the City of Indianapolis with ingress and egress for passengers, materials and merchandise coming to or going from such premises, such owners or occupants having complied with the provisions of Section 26 of General Ordinance No. 96, 1928, as amended by General Orinance No. 31, 1931, as amended by General Ordinance No. 58, 1931, relative to the establishment of passenger and/or loading zones, at the place hereinafter set out, and the Board of Public Safety having caused investigation to be made thereof and having recommended the establishment, pursuant to the terms of the aforesaid ordinance, the following passenger and/or loading zone be and the same is hereby established in the City of Indianapolis, to-wit:

> An 18 foot zone in front of 20-24 Virginia Avenue, said premises being occupied by the Central Wall Paper and Paint Corporation.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
