APPROPRIATION ORDINANCE No. 2, 1939

AN ORDINANCE appropriating Fifteen Thousand Dollars (\$15,000) from the unappropriated and unexpended 1938 balance of the general fund of the Department of Health and Charities and allocating the same to certain designated funds of said department, and fixing a time when the same shall take effect.

GENERAL ORDINANCE No. 4, 1939

INTRODUCTION OF GENERAL ORDINANCES

By the Board of Public Safety:

GENERAL ORDINANCE No. 12, 1939

AN ORDINANCE regulating the parking of vehicles upon the streets of the City of Indianapolis, providing a penalty for violation thereof, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. It shall be unlawful for the operator of any vehicle to park the same for a longer period than one and one-half hours between the hours of 7:00 A. M. and 6:00 P. M., on the south side of East Eleventh Street, from Brookside Avenue to Arsenal Avenue.

Section 2. Any person violating any provision of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00), to which may be added imprisonment not exceeding one hundred eighty (180) days.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the mayor, and publication according to law.

Which was read the first time and referred to the Committee on Public Safety.

By the Board of Public Safety:

GENERAL ORDINANCE No. 13, 1939

AN ORDINANCE regulating traffic upon certain streets in the City of Indianapolis, providing a penalty for the violation thereof, repealing all ordinances in conflict therewith, and particularly repealing the following ordinances, to-wit: General Ordinance No. 100, 1938, as amended; General Ordinance No. 19, 1938,

as amended; General Ordinance No. 51, 1936, as amended; and General Ordinance No. 61, 1935, as amended; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the use of the following named streets of the City of Indianapolis is hereby prohibited for all automobiles weighing over one (1) ton, except passenger cars or motor buses devoted to the carriage of passengers for hire, to-wit:

- (a) Meridian Street, from Sixteenth Street north to the city limits.
- (b) Thirty-eighth Street, from Northwestern Avenue to Keystone Avenue.
- (c) Westfield Boulevard, from College Avenue to Sunset Avenue.
- (d) Union Street, from Merrill Street to Adler Street.

Section 2. Any person violating any of the provisions of this ordinance shall, upon conviction, be fined in any sum not exceeding Fifty Dollars (\$50.00), to which may be added imprisonment not to exceed ten (10) days.

Section 3. All ordinances and parts of ordinances in conflict herewith are hereby repealed, particularly the following ordinances, to-wit: General Ordinance No. 100, 1938, as amended; General Ordinance No. 19, 1938, as amended; General Ordinance No. 51, 1936, as amended; and General Ordinance No. 61, 1935, as amended.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval by the mayor, and publication according to law.

By City Councilman Ollie Bach:

GENERAL ORDINANCE No. 14, 1939

AN ORDINANCE regulating the parking of vehicles upon certain streets of the City of Indianapolis, providing a penalty for violation thereof, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. It shall be unlawful for the operator of any vehicle to park the same, or suffer, permit or allow the same to be parked for a longer period than one and one-half hours between the hours of 7:00 A. M. and 6:00 P. M. on the following named streets, to-wit:

- (a) Frank Street, between Meridian and Pennsylvania Streets.
- (b) LeGrande Avenue, between Meridian and Pennsylvania Streets.
- (c) Meridian Street, between Morris Street and Pleasant Run Parkway, North Drive.
- (d) Raymond Street, between Meridian and Pennsylvania Streets.
- (e) Regent Street, between Meridian and Pennsylvania Streets.
- (f) Schiller Street, between Meridian and Pennsylvania Streets.

Section 2. It shall be unlawful for the operator of any vehicle to park the same, or suffer, permit, or allow the same to be parked at any time on the following portions of the following street, to-wit:

(a) On both sides of South Meridian Street, from Schiller Street to the Bluff Road.

Section 3. Any person violating any provision of this ordinance shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00), to which may be added imprisonment not exceeding one hundred eighty (180) days.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval by the mayor, and publication according to law.

Which was read the first time and referred to the Committee on Public Safety.

By the Department of Public Purchase:

GENERAL ORDINANCE No. 15, 1939

AN ORDINANCE authorizing the Board of Public Works and Sanitation to purchase certain materials and supplies to be paid for out of the Gasoline Tax funds heretofore appropriated, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the Board of Public Works and Sanitation of the City of Indianapolis, through its duly authorized purchasing agent, be and it is hereby authorized and empowered to purchase the hereinafter estimated season's requirements for the necessary materials and supplies used in the repair, upkeep, maintenance and improvement of all public streets, thoroughfares and roadways in the City of Indianapolis, the said materials and supplies to be purchased from the lowest and best bidder, or bidders, whose bids have heretofore been received and opened in public by said board after advertisement therefor, and the total cost of said materials and supplies shall not exceed the sums of money as hereinafter set out, to be paid out of the Gasoline Tax funds heretofore appropriated for use of said board:

Requisition No. 381—100,000 gals. (more or less) Refined Asphalt	10
Requisition No. 1230—240,000 gals. (more or less)	20

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by the mayor.

March 1, 1939.

Hon. Daniel L. Bower, Chairman, Committee on Affairs of the City of Indianapolis, House of Representatives, State House, · Indianapolis, Indiana.

My dear Dr. Bower:

I am directed to inform you that the members of the Common Council of the City of Indianapolis are definitely opposed to any legislation now pending that involves an increase of salaries of city councilmen for the City of Indianapolis.

Although the present salary of \$600.00 per annum is greatly disproportionate to the time and effort that the office entails, yet that very fact prompts one in seeking the office to be moved primarily by a desire to render a public service and civic duty rather than by a desire for selfish gain.

If this legislation comes before your body on third reading, I trust you will find opportunity to convey to the members of your body the sentiment of the members of the present City Council of Indianapolis.
