INTRODUCTION OF GENERAL ORDINANCES

By the Board of Public Safety:

GENERAL ORDINANCE No. 27, 1939

AN ORDINANCE to restrain and punish any known prostitute or any known gambler or any person known or reputed to be such from entering into or remaining or loitering in any public room or corridor of a hotel, and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. It shall be unlawful for any known prostitute or any known gambler or any person known or reputed to be such to enter into or to remain and loiter in any public room or corridor of any hotel within the City of Indianapolis: Provided, that the provisions of this ordinance shall not apply to any such person who is a guest of any such hotel and duly registered at such hotel as such, or who is visiting a duly registered guest at such hotel: and Provided further, that the provisions of this ordinance shall apply only to such person or persons who shall have been forbidden to enter into or remain or loiter in the public rooms or corridors of any such hotel by the owner, proprietor, or manager thereof, or by his agent or servant.

Section 2. Whoever, being about to enter into any such public room or corridor of any hotel in the manner herein defined as being unlawful, or whoever, being in such public room or corridor, shall be notified to depart therefrom by the owner, proprietor, or manager, or his agent or servant, shall thereafter enter into, or neglect or refuse to depart from such public room or corridor of such hotel, shall, upon conviction, be fined in any sum not exceeding Fifty Dollars (\$50.00), to which may be added imprisonment not exceeding ten (10) days.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the mayor, and publication according to law.

One (1) Truck—heavy duty—for hauling ash and garbage trailers, as per specifications......\$3,700.00

BOARD OF PUBLIC WORKS AND SANITATION ALL DEPARTMENTS

Approximately 20,000 gallons of Gasoline per month, making a total estimated expenditure for one (1) year's supply......\$30,000.00

Section 2. That each of said purchases shall be made from the lowest and best bidders thereon whose bids have been received after advertising for competitive bids therefor, according to law, and the total cost of the same shall not exceed the sums of money as hereinabove set out opposite each purchase. 11161
