INTRODUCTION OF APPROPRIATION ORDINANCES

APPROPRIATION ORDINANCE No. 10, 1939

- AN ORDINANCE appropriating Five Hundred Dollars (\$500.00) from the unappropriated and unexpended 1938 balance of the general fund of the City of Indianapolis and allocating the same to a certain designated fund of the Department of Finance, for the purpose of providing the office of the City Clerk with sufficient funds to pay for printing and advertising, as required by law; and fixing a time when the same shall take effect.
- WHEREAS, an extraordinary emergency now exists in the Department of Finance for additional funds to supplement the funds provided for in the 1939 budget of said department, in order for said department to accomplish the following, to-wit: to pay for the printing of the Proceedings of the Common Council. and other incidental printing required by the office of the City Clerk for the remainder of the fiscal year 1939; and to publish ordinances and legal notices required by law to be given by the city clerk for the remainder of the fiscal year 1939; and
- WHEREAS, there remained in the various numbered funds of certain departments of the City of Indianapolis on December 31, 1938, unexpended balances, which balances in certain funds by operation of law reverted on January 1, 1939, to the General Cash Balance of the City of Indianapolis, and said fund is now in excess of the sum of Five Hundred Dollars (\$500.00); NOW, THEREFORE,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

Section 1. That the sum of Five Hundred Dollars (\$500.00) is hereby appropriated from the uanappropriated and unexpended 1938 balance of the General Fund of said city, and allocated in like amount to the following designated fund, as per 1939 budget classification, in the Department of Finance, and to be expended for the following purpose:

Fund No. 24.—Printing and Advertising—\$500.00

to be expended for the printing of the Proceedings of the Common Council of the City of Indianapolis and other incidental printing required by said office and for the publication of legal notices and ordinances as required by law to be given by the city clerk.

AN ORDINANCE prohibiting any person harboring a dog to allow, permit or suffer such dog to be in certain places unless muzzled or on a leash, providing a penalty for the violation thereof, providing for the impounding of dogs; and fixing a time when the same shall take effect.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF INDIANAPOLIS, INDIANA:

- Section 1. That it shall be unlawful for any person who harbors a dog to allow, permit or suffer such dog to be upon a street, public place or on any property without the consent of the owner or the party in possession of such property, unless such dog is effectively muzzled or restrained by a chain or leash not exceeding six (6) feet in length and held securly by a responsible person.
- Section 2. Any dog found anywhere in violation of any provision of this ordinance may be impounded by any police officer in the same manner and subject to the same conditions as now provided by ordinance for the impounding of dogs.
- Section 3. Any person violating any of the provisions of this ordinance shall, upon conviction, be fined in any sum not exceeding One Hundred Dollars (\$100.00).
- Section 4. This ordinance shall be in full force and effect from and after its passage, approval by the mayor, and publication according to law.

M. and 6:00 P. M. on the following streets in the City of Indianapolis, to-wit:

- (a) Both sides of Illinois Street from the south curb line of Merrill Street to the north curb line of McCarty Street.
- (b) West side of Leon Street between Michigan Street and North Street.
- (c) Both sides of Shelby Street between Woodlawn Avenue and Morris Street.
- (d) Both sides of Virginia Avenue between Woodlawn Avenue and Prospect Street.
- (e) Both sides of Prospect Street between Hunter Street and Olive Street.
- (f) Both sides of Woodlawn Avenue between Virginia Avenue and Shelby Street.

Section 2. Any person violating any provision of this ordinace shall, upon conviction, be fined in any sum not exceeding Three Hundred Dollars (\$300.00), to which may be added imprisonment not exceeding one hundred eighty (180) days.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval by the mayor, and publication according to law.
