3 in Square No 48 in the Town of Indianapolis on said Croppers conveying in due form of law, clear of all incumberance lot No. 2 in said Square to the Common Council of the town of Indianapolis and also pay into the Treasury of said town the sum of \$50: and also all costs and charges incurred by the Corporation in reference to said exchange of lots as aforesaid.

James Vanblaricum was appointed collector of the Revenue for the town of Indianapolis for the year 1839.

Ordered that the road tax due by the Ministers of the Gospel in the town of Indianapolis be remitted.

An Ordinance to provide for the improvement of the side walks, was read, amended and passed and ordered to be published.

An Ordinance to regulate proceedings and prosecutions before the President of the Common Council of the town of Indianapolis. was read, amended, passed and ordered to be published.

An Ordinance to restrain the Licensing of Groceries and Tippling houses in the town of Indianapolis & for other purposes, was read, amended, passed and ordered to be published.

An Ordinance for the Appointment of a town Auctioneer and to provide for Licensing itenerant Auctioneers, was read, amended, passed and ordered to be published.

An Ordinance to provide for the Appointment of town Surveyor and Engineer and to define his duties and Compensation, was read, amended, passed and ordered to be published.
