George Norwood presented a petition, asking the privilege of taking gravel from Louisiana Street for side walk - which petition was granted on condition that sd. Norwood grades where he takes the gravel.

Ordered that \$20: be appropriated for sewers and foot walks in addition to what has heretofore been appropriated to the second ward - and also that two sewers be made on Georgia Street across Illinois Street by the Marshal.

On Motion of Mr. Seibert Ordered that the Marshal cause to be made two foot walks across Illinois Street on Ohio Street

On Motion of Mr. Seibert Ordered that \$15: be appropriated to repair Delaware Street north of Massachusetts Avenue.

On Motion of Mr. Seibert

Ordered that the Marshal be directed to grade the mouths of the alleys at Lister Stable and at Delaware on the East side of Illinois and also at Mr. Norwoods.

Ordered that the Marshal make a gravel walk across Tennessee Street on the north side of Washington Street. 1

The following petition was presented to the Council viz "To the Common Council of the Town of Indianapolis Indpls Ind. The undersigned your petitioners being the owners of a majority of the number of feet on the west side of Meredian Street between Washington Street & Louisiana Street would ask your honorable body to pass such order or law as may be neccessary to authorize and compel the property holders between said points as aforesaid to grade and gravel the side walks from said Washington Street to Louisiana Street on the West side of Meredian Street - and further your petitioners ask that your honorable body will grant to them the privilege of taking gravel for the purpose from the bluff in Louisiana Street under such restrictions as may be proper, and your petitioners as in duty etc.
