Council Chamber Indianapolis November 5. 1842

Council met; present Messrs Cully President, Black Goldsberry Nowland Loudon and Rickards of the Council.

Mr Black presented the petition of H. O'Neal & others praying that Mr Robinson be permitted to place a sign across the side walk at the Palmer House = the prayer of said petition was granted.

The President - laid before the Council the Weighmasters monthly report which was read and received.

Mr. Loudon presented the Treasurers monthly report which was read and received.

Mr Black from the committee on claims reported that the bill of Messrs Bolton & Pattison refered to said committee had been paid to them by an allowance made on 17 June 1941 and asked to be discharged from the further consideration of said subject, the committee was discharged.

The President laid before the Council the resignation of Carey H. Boatright Councilian for the Sixth ward which was accepted.

On Motion of Mr Black the Council proceeded to fill the vacancy in the Council occasioned by Mr Boatrights resignation Whereupon

Mr Samuel S. Rooker was appointed Councilman for the sixth ward to serve as such until the annual election.

I'r S.S. Rooker appeared & took the necessary oath and took his seat in the Council.

On Motion of Mr. Loudon

Resolved That the Committee on streets and alleys be directed to inquire whether the owners of property on the west side of Illinois Street between Washington and Louisians Streets have complied with the orders of the Common Council on the subject of side walks and report thereon.

Ir. Loudon presented the application of David Lloyd for License to retail spirits as a Grocery Keeper in the town of Indianapolis which being examined and understood

Ordered that the Secretary issue license to David Lloyd to retail spirits in said town for one year from 4 November 1842 upon said Lloyds presenting the Treasurer receipt for the sum of \$100. and otherwise complying with the ordinances of said town. Mr Black from the committee on Markets & Market houses to whom had been refered the subject of repealing the 23rd section of the ordinances regulating markets and market houses reported that it was inexpedient to repeal said section of said ordinance. When on motion of Mr Goldsberry the report was not concurred in. And on motion of Mr Goldsberry said committee were directed to report at the next meeting of the Council an ordinance to repeal the 23rd section of the ordinance regulating Markets & M rket houses.

Allowed H & H. Brown \$25:00 for services rendered as attys in the year 1841.

Mr Black from committee on claims to whom the subject had been refered reported that was on overcharge in T. Maughs bill for blacksmithing of \$2. and recommended that E Maugh be allowed \$6 in full of said Bill which was allowed. (Issued 7 Nov. to A)

Allowed R.C. Allison \$7:18 for removing nuisances & for watering pot as per account riled

(Issued 7 Nov)

Allowed R C Allison \$27:15 for labor paid and done on Virginia Avenue in repairing the same as per order of Council. (Issued 7 Hov.)

On Motion of Mr Foldsberry Ordered that the Marshal be directed to make foot walks across Alabama Street south of Market Street also across Market Street East of Alabama Street.
