Allowed Jas Vanblaricum \$1.60 for removing nuisances up to this date as per act. filed.

Mr. Nowland from the Committee to whom was refered that subject reported An Ordinance entitled "an Ordinance to amend an Ordinance entitled "An Ordinance to restrain the licensing of Groceries and Tippling houses in the town of Indianapolis, and for other purposes," Ordained and established the 10th day of June 1839, providing for Tavern keepers to take out license to sell ardent spirits at retail within the town of Indianapolis at fifty dollars per annum. Mr. Griffith moved that a clause be inserted in the first section to levy a tax of one hundred dollars on Groceries and Tippling houses. Mr. Montague moved to lay the proposed amendment on the table -- carried. Mr. Nowland moved to amend the first section by inserting Groceries and Tippling houses after the word Tavern keepers -- carried. Mr. Goldsberry moved to strike out fifty dollars in the first section and insert one hundred dollars -- not carried. The question the recurring on the adoption of the Ordinance as amended, and the ayes and naes being called for, it resulted as follows: Ayes Louden, Montague, Nowland and Rooker. Noes Messrs. Griffith and Goldsberry. So the Ordinance was ordained and established. And the Secretary Ordered to have the same Published.
