On Motion of Mr Rooker

Ordered That the fine assessed by the President against Mr. Philip Ennis be remitted upon his paying all costs of suit.

On Motion of Mr. Goldsberry

Resolved That a committee, to consist of three persons selected from the body of the Citizens, be appointed, be appointed, to examine and report in writing to the Council, at the earliest practicable period, The Stove Pipes in the town that are so kept, and are now in the condition to endanger property by Fire; and what repairs and improvements or alterations, if any, are necessary to be made to each and every Pipe so examined, to prevent the same from setting fire to any property in its immediate vicinity; Also to examine and report the number of Ladders, and their Lengths, now kept in or about each Square in the central part of the town, and what number of Ladders, and their Lengths, should be required to be kept within each of said squares, or the number requisite for each house in said squares; and also That said Committee report the number of Fire Buckets now kept in, or belonging to each house, which they may visit for the purposes aforesaid; and the number by them deemed necessary to be kept in each house so visited.

Jno. N. Wright, C. N. Boatright & T. M. Smith were appointed said Committee.

Ordered That the Secretary furnish said Committee with a copy of the above Resolution.

On Motion of Mr. Rooker

Ordered That the fine assessed by the President against James Vanblaricum upon his paying all costs of suit within thirty days from this date - See Dock No 1. Page

The President laid before the Council the Petition of John Montgomery John Keely, and others praying the Council to cause New York Street to be opened, east from East Street to the line of the Donation, which was read, the prayer of the Petitioners granted, and the Supervisor Ordered to notify those having the said Street inclosed to open or cause the same to be opened within ninety days from this date, and if the same is not opened within said time, to proceed to do the same according to law.

- 26. Allowed Samuel Goldsberry \$8.372 hauling gravel as per act.
- 31. Allowed Martin Bykit 50 cts for repairing Pump at Corner of W. & W. streets.
