
The council convened in regular meeting. Present a full council except Mr Harrison.


Mr King, from the Special committee to whom was referred the examination of the Ditch recently constructed by Order of the late common council, reported progress and asked further time which was granted.

Mr Tutewiler presented the petition of sundry citizens praying the city council to Order & direct the finishing of the grading of Pennsylvania Street, and also to permit the petitioners to gravel said street in the center Twenty feet in width and eight inches in depth, and aid them by an appropriation of a sum of Money equal to that which may be appropriated for a similar purpose on Meridian or Delaware Street. Which petition was read & referred to the committee on Streets &c to report at a meeting of the council to be held this day two weeks hence.

Mr King, presented the Petition of sundry citizens of Illinois Street praying the council to grant the privilege to gravel the side walks on each side of said street, and to compel such owners of property on said street who do not join in said petition to gravel the sidewalks in front of their property Which petition was read, and referred to a select committee consisting of Messr King, Cady & Wingate with instructions to report an Ordinance providing generally for such improvements, at a meeting of the council to be held this day two weeks hence.





Beleiving as I most solemnly do, that an alliance of a most unjust and unholy character, has been entered into between four of the newly elected members of the council, for the purpose of thwarting and defeating every measure of importance or not, which may be introduced for the benefit of the ward, I have had the honor to represent, - and feeling that such an alliance, has been conceied and brought forth from principles, derogatory to the character of honorable men, - And beleiving that the same spirit which dictated this alliance, will lead to the disbursement and expenditure of monies unjustly, whereby a certain portion of the city will be deprived of rights, which they had reason to expect they would receive at the hands of the council -- I have determined to retire from the body over which you preside, and hereby tender my resignation as a member of the city council.
