Council Chamber Indianapolis June 19. 1848.

The Council met pursuant to adjournment. Present a full council except Mr Eaglesfield.

The proceedings of the last meeting were read & approved.

The President laid before the council an Estimate of a culvert across Washington Street at intersection of New Jersey Street, and excavating a Ditch on West side of New Jersey Street South of Washington. which was read, and ordered to be filed.

The President laid before the Council, the returns of the election held in the several wards on the 10th inst, for and against a Tax for the purchase of an additional Fire Engine, showing the aggregate vote to be One hundred and seventy eight, of which Fighty six were for Tax, and ninety two were against it. - Ordered to be filed.

Allowed, Joseph Willis \$5.00 for specifications & plan of City Hospital

Mr Brandt, presented an account of Turner & Blake amounting to Sixty one dollars. for Brick &c. which was read, and laid upon the table.

Mr Alford from the Standing Committee on Public Wells &c. reported verbally upon their condition and recommended their immediate repair. Whereupon:

Ordered That the Committee on Public Wells, have the same thoroughly cleansed and repaired at the earliest practicable period, and at the lowest price.

Ordered That George W Moore, have privilege to place a public well on the sidewalk Opposite his property on Indiana Avenue under the superintendance and direction of the committee on public Wells.

Mr Tutewiler, on behalf of sundry Owners of Property on the east side of Pennsylvania Street, between Washington & Vermont Streets, asked a renewal of the Order adopted on the 6th of September last, authorizing the grading and gravelling of the side walk on the east side of said Pennsylvania Street, between the points aforesaid, agreeably to their petition presented and granted at the time aforesaid. Whereupon.

Ordered That the Order adopted by the city council at their meeting on the 6th day of September, 1847. relative to the grading and gravelling the side walk on the East side of Pennsylvania Streets. between Washington and Vermont Streets, be and the same is hereby renewed, And that the city engineer is hereby directed to make survey and establish grade marks for said improvements,

notifying the Commissioner of Streets thereof as required by the provisions of Ordinance No 2. adopted June 21. 1847.

Ordered That 250 copies of so much of the Ordinances on the Subject of Nuisances, as relates to the feeding of horses &c. on certain streets of the city be printed in Hand bill form. And posted by the Marshall.

Mr Alford, presented the following petition, viz.

To the City Council of Indianapolis.

The undersigned owners of the major number of the feet of Ground on both sides of Indiana Avenue from the junction of Ohio & Illinois Streets to the junction of Vermont & Mississippi Streets, being desirous of grading and gravelling the Avenue between the points aforesaid, under the provisions of Ordinance No 2. of the city Council, adopted June 21. 1847, very respectfully ask your honorable body to pass an Order therefor.
