It was Ordered. That the President issue his proclamation for such election upon the presentation to him of a peition of 30 voters and that said election be governed in every respect by the provisions of the resolution adopted May 27. 1848 so far as. the levy for Such purpose is concerned.

Mr Henning & Powers petitioned the council to purchase the right of the contractors to use Chapman Warner forcing lifting Patal Pump - whereupon On motion The subject of said purchase was referred to the committee on public Wells.

The President laid before the Council the resignation of James Wood City Surveyor and Engineer, which was read and laid upon the table.

Ordered That the City Engineer be and he is hereby authorized to engage an assistant who shall be allowed the Sum of One dollar. per day and in the same proportion for such time as he may be actually engaged.

The President laid before the Council the assessment returned by Charles J Hand, assessor for the year 1848. which was received.

Ordered That there be assessed, levied and collected on the assessment returned by the Assessor of the City of Indianapolis for the year 1848. On each One hundred dollars thereof Fifteen cents for General purposes, & Twelve cents for School purposes -Also One dollar on each person chargeable with a Poll tax, One dollar on each person chargeable with a road tax, and fifty cents on each day.

Ordered That Tuesday the 11th day of July inst at 2 oClock P.M. at the Council Chamber be the time and place appointed to hear and determine any and all appeals that may be taken from the assessment returned for the year 1848.

The President reported an Ordinance No 1. which was referred to a Special Committee consisting of Mr Mayhew & the President.

A petition from the Marion Engine Fire Company asking an appropriation for the purchase of & repair of Hose belonging to Said company was received, read, and referred to the Committee on the Fire department

Ordered. That the clerk of the Market, be and he is hereby authorized to rent the outside benches at both Market houses to such persons as may apply therefor at such rates and for such length of time as may be deemed by him just & reasonable.

And the Council adjourned to meet on the 11" inst at 2 oClock P.M.
