Resolved, That hereafter all subjects presented to the council, for their action, or consideration, shall be submitted in writing.

On motion by Mr Alford.

Resolved. That the Commissioner of Streets, be and he is hereby required to report to the city council, at their next regular meeting. the condition of the grading and gravelling on Indiana Avenue, showing, as well the names of those persons who have performed said grading and gravelling On said Avenue, as those who have not. - Also the condition of all other Streets, for the grading and gravelling of which assessments have been made during his term of Office, specifying the quantity of grading and gravelling yet to be performed On Said Streets and by whom.

And the council adjourned.
