The City Council of Indianapolis met pursuant to notice for the purpose of considering and determining the matter growing out of the petition of the Penn & Indianapolis Rail Road Company to use East & Alabama Streets with tracks for the road. Present Geo. A. <sup>C</sup>hapman President, Messrs. Brandt, Tutwiler, King, Mayhew & Sibert of the Council.

Mr. Tutwiler, moved that the prayer of the petitions be not granted. And the yeas and nays being demanded. Those who voted affirmative were Messrs. Brandt, Tutwiler & King. 3. Those who voted negative were Messrs. Mayhew Sibert & President. 3. Lost.

A Remonstrance having been presented by citizens of Alabama Street under the provisions of the Ordinance, showing a large Majority opposed the use of said Street for such Rail Road track, either by Steam or Horse power. Said Street was therefore exempted from such track.

Remonstrances were also presented against the use of East Street for such Rail Road track, use of which provided a restriction to be imposed upon the Company Whereupon - Mr. Tutwiler moved that the use of East Street be granted for such Rail Road track under restrictions of Remonstrance marked No. 2. And the yeas and nays being demanded. Those who voted affirmatively were Messrs Mayhew, Sibert & Mr. President 3. Those who voted Regatively were Messrs. Brandt, Tutwiler & King 3. Lost.

Mr. Sibert moved that the use of East Street be granted to said Rail Road Company without other restrictions than those expressed in the Ordinance on that subject and the yeas and nays being demanded. Ayes Mr. Sibert & the President 2. Naes Messrs. Brandt, Tutwiler, King & Mayhew 4. So the prayer of the petitions for the use of either or both of said Streets for a Railroad track was not granted.

On Motion by Mr. Mayhew, Lot No. 35 & 36 in the Washington Hall Company subdivision of the  $N_{\Xi}^{\perp}$  of Square No. 98, was selected as the Site of the Fire School House in the Sixth Ward, and the sum も同様
