Mr. Sulgrove presented the following petition: To the Hon: the City Council of Indianapolis



That all strolling Musicians, signers, organ players, and persons giving exhibitions of any kind in the public streets, and taking money therefor, shall be declared nuisances and on conviction thereof, be fined not less than one dollar each for the first offense, and the fine to be increased at the discretion of the Mayor for any subsequent offense.
