- Sec. 2. The Treasurer of said city is hereby prohibited from receiving and giving a receipt for any money tendered to him, for a license for any such exhibition.
- Sec. 3. Any person or persons who shall exhibit any such Menagerie or circus within the limits of said city without a license therefor, signed by the President and Secretary of the City Council as required by section 23, of the Charter of said city, shall forfeit and pay for each day such exhibition shall continue any sum not less than One hundred dollars nor more than three hundred dollars, to be recarried in an action of debt before the Mayor of said City.
- Sec. 4. Any person or persons who shall permit any such exhibition on his, her, or their premises, without a license from the constituted authority of said city, shall forfeit and pay any sum not exceeding One hundred dollars, to be recarried in the manner aforesaid.
- Sec. 5. All ordinances, and parts of ordinances conflicting with the provisions of the above ordinance are hereby repealed.

Ordained and established this 16th day of July 1849, to take effect and be in force from and after its publication as required by the Charter.

This being the day appointed to hear and determine appeals from the assessment returned by the City Assessor, for the year 1849; and there being no appeals taken, the Council proceeded with other business.



On Motion of Mr. Sulgrove Resolved, That the Marshal be directed to notify the President of the Board of Trustees of the Marion County Seminary, to abate the nuisance occasioned by the water from the Pump on the Seminary grounds, without unnecessary delay.

Ordered. That the Marshal be and he is hereby authorized to contract for four thousand feet of Sound Oak plank, for the use of the city, of the following dimensions viz Two thousand feet, 2 inches thick 18 inches wide, and ten feet long, and Two thousand feet $2\frac{1}{2}$ inches thick 1 foot wide and 12 feet long.

Resolved. That Drs. Thompson, Harrison & Funkhauser, be and they are hereby consituted a Board of Health, for the City, to serve as such for the term of One year from the date of their respective appointments, made at a previous meeting of the Council.
