The council met, Present Messrs Bates, Culley, King, Rooker, Sulgrove, & Montague and Mr President.

The proceedings of the last three meetings were read and approved.

The Treasurer submitted his report of the Receipts and Expenditures during the Month of Nov last past which report and accompanying vouchers, was read and ordered to be filed.

The Commissioner of Streets reported the following claims for work and labor, under his superintendance, which were allowed as follows viz.



Account of David Sibert for \$15.27 for 3 months & 2/3 of a month for services as Messenger, allowed.

Ordered, That the commissioner of streets be directed to cause a gravel walk to be made across Market Street, where Circle Street crosses the same on the west side.

On motion, Privilege is granted to Mr Irwin to repair the grade of Pennylvania Street in the vicinity of Morris and Irwins Saw mill, provided he removes the earth for that purpose in conformity with the city profile of grades and makes such repair at his own expense.



Mr Montague, from the committee on the Fire Department who were charged with the duty of tendering the orders of the city (under the provisions of the Order of Nov 20" 1849) to the Independent Relief Fire Co. for three hundred dollars, for the purchase of the "Good Intent Engine" reported the contract

as having been made, between the council and the Independent Relief Fire Co. and that upon the issue of the orders the latter company are to deliver the aforesaid Engine to the council.

Which report was concurred in.

Ordered, That the orders be issued to said company in denominations of \$20.00 (Issued 461 to 475 inclusive)

(512) Allowed John S. Watts, \$20.00 for ground rent of Engine house to June 7, 49.

Ordered, That the street Commissioner erect Foot bridges across Meridian Street on the north side of Maryland, - on the west side of Pennsylvania at the crossing of New York, & across Illinois at the crossing of Vermont.

Ordered, That the Marshal purchase a sett of common chairs for the use of the council,

Ordered That the City Engineer set stakes for the excavation of a new course for Pogues Run through the land of A W Russell, whenever Mr Russell shall signify his wish to proceed with said excavation.

Ordered, That the Street Commissioner make a gravel walk across Alabama Street at the crossings of Washington Street, and gravel the mouth of the alley in Square No 59, on East side of Alabama Street.

Ordered That the Treasurer purchase one cord of wood for the use of this chamber and have the same sawed ready for use.

Ordered, That the Street Commissioner make foot bridges on Mississippi Street at crossings of Washington Street, also to repair the side walk on the Street on the west side of the canal on Washington Street.

The Secretary made application for additional compensation, which application after some discussion was withdrawn.

The Secretary presented a resignation to take effect from and after the 10" inst, which was accepted.

And the council adjourned.

The Council met, Present Messrs Culley, King, Sulgrove, Montague & Mr President.

The proceedings of last meeting were read and approved.

(412) Ordered, That David King be allowed ten dollars in part for building a bridge across New York Street.

On motion, the council proceeded to elect a secretary to fill the vacancy occasioned by the resignation of the present incumbent, Messrs King & Montague acting as tellers. And on the first ballot Joseph T. Roberts having received a majority of all the votes cast was declared duly elected.

And an motion, the Council adjourned until 10 inst at $\frac{1}{2}$ past 6 P.M.
