  \$3.30 for Hardware, for Hook & Ladder Company.

The following proceedings of a meeting of the Citizens of the Western Liberties in refference to the organization of a Fire Company were Read, and ordered to be spread upon the minutes,

At a meeting of the Citizens of the Western Liberties held at the Factory of Messrs Guisendorf's Dec 7th 1849 for the purpose of organizing a Fire Company; John Carlile was called to the chairs, and E. H. Conningham appointed Secretary.

On motion of D Carlile, Resolved, That this Company be known by the name of the Independant Western Liberties Good Intent Fire Engine and Hose Company. The meeting then elected the following officers for the next three months, viz John Carlile President, E. H. Cunningham Secretary, and John McCutchen Treasurer,

On motion Resolved, That there be a committee of three appointed to act as a standing committee for the next three months, Whereupon the following persons were appointed said Committee, William Guisendorf, R. Kellogg and D. Carlile, On motion a committee

of three were appointed to draft a constitution and Bye Laws for the government of said Company, and to Report at the next meeting. Resolved that Thomas M. Brickett, Robert M. Dempsey and Robert Greenfield be appointed said Committee.

On motion Robert Greenfield Wm. Woods and John McCutchen be appointed a committee to procure a Room for the "Higgins family" and that it shall be the duty of said Committee to see to receiving the proceeds of the concert and placing the same in the hands of the Treasurer of this company.

On motion the meeting adjourned to meet at this place on Wensday Evening next, Dec 12th at  $6\frac{1}{2}$  Oclock P.M.

E. Conningham Secty John Carlile Prest.

On motion of Mr King, the following preamble and Resolution were accopted.

Whereas it appears by the proceedings of a meeting held in the western part of the City, that a Fire Company has been organized under the name of the Independant Western Liberties Good Intent Fire Company, Therefore,

Resolved That the City Council donate to said Company, the Engine Good Intent with such apparatus as may belong thereto, including the Torch lights, Hose and Hose Carrige, which formerly belonged to said Engine, to be used by said Company so long as they shall continue organizied for the suppression of fire throughout the City.

On motion of Mr Sulgrove the following Resolution was adopted.

Resolved, That the Hose and Hose Carraige now in the possession of the Marion Fire Company transfered thereto by an order of the Council January 2nd 1949, be and the same is hereby transfered to the Independant Western Liberty Good Intent Fire Company.

And on motion the Council adjourned.
