The following petition was presented by Mr. Carlisle. To the Honorable Members of the Common Council of Indianapolis:

We, the subscribers of Marion County, State of Indiana residing close to and on the West side of White River in Center Township in what is commonly called "West Indianapolis" being desirous of admission into the corporate lines of the city of Indianapolis, and, to become a part of said corporation, and enjoy all the rights and privileges guaranteed to the same would respectfully petition your honorable body to extend the corporate lines of said city on the West to the present donation line, making said corporate line, as extended, run with and on, the Western donation line across the National Road and include all land now within the donation line west of White River, which if extended as prayed herein will place all the petitioners hereto within the corporation.

We pray the above upon the following conditions that, whereas, the Central Plank Road Company have erected a toll gate upon the "ational Road adjoining to and on the East side of White River Bridge, requiring toll of each and all persons crossing said bridge and consequently there being no free communication from our several residences to the city, which if not unjust and extortions under existing circumstances would certainly become so in the event of our incorporation as a part of your city, and whereas, it will be seen by reference to the Revised Statutes, Vol. 1st Page 215 that

"The Common Council shall have exclusive power over the Streets, highways, alleys & Bridges within such city, and to lay out, survey, open, straighten, widen, or otherwise alter the same." And

They may cause buildings and structures in the way of any street or public improvement to be taken down and appropiated, etc."

Therefore, as your honorable body has the exclusive power in the control of said toll gate, and as a condition precedent to our admission as a part of said corporation, we pray that the same may be removed from its present location to such other place as you may direct, and will at the same time relieve your petitioners from the payment of toll in their communication with different parts of the city, or in the event your body does not see proper to comply with the above condition that in line of the same you erect or cause to be erected a suitable bridge across White River which will be accessable from the National Road on each side of said river, and will not subject us to the payment of toll. Signed by Wm Schoolcraft, & 34 others.

We, the undersigned respectfully ask your honorable board to pass an ordinance for the renting of the vegetable stands in the East & West Market at such a price as would enable those attending Market regularly to have an established place where his customers could find him, the present price of \$5 is, in our opinion, too much or more than the sales of vegetables will justify us to pay & we believe a less price will yield more revenue to the town, there are some eight or nine that are unwilling to pay the price but are willing to

give \$3. in each Market, beside you must recollect there are five months or nearly that, that we can sell but little if any things in our line in the Market, the groceries have all the custom or they are willing to buy our produce at prices to suit us both, & thereby avoiding the chilling blasts of wintry winds which necessary attends an attendance upon the Markets during the winter months.

Your early attention to our petition will confer a favor on your obedidient servants.

The number of each house shall be designated by the aforesaid Commissioner, and completed within thirty days from the time of notification. The expenses to be borne by the respective property holders.

Resolved, That the Superintendent of the Central Canal be requested to let the water in the Northern Division of the Central Canal as soon as possible, as it seems to be the opinion of physicians and others that in its present contition it is prejudicial to the public health.

On Motion Laid on the table. Mr. Karn offered the following: Resolved, That the committee on Revision be instructed to report an ordinance prohibiting the posting of show bills &c, on buildings without the consent of the owners." On Motion Laid on the table. Mr. Maguire offered the following for adoption: Resolved, That any member presenting a petition or offer-ing a resolution, shall rise in his place, address the chair, and present them through the President for the consideration of the Council. Which was adopted by the following vote Those who voted in the affirmative were Messrs.
