Mr. Maguire from a select committee on that subject pre-

sented the following report:

"The committee to whom was referred the assessment roll of the property of the City of Indianapolis, with instructions to confer with the assessor and report to the Council whether in their opinion it was in a condition suitable to be accepted, now report that they immediately after their appointment examined the said assessment roll, and found it unsuitable for acceptance. The property belonging to the same individuals is found sometimes scattered in several parts of the books, some of the extensions were erroneous, and quite a considerable amount of property was omitted altogether. There were various erasures and interlineations which made it difficult sometimes to determine with certainty the amounts intended to be charged, and the figures were so placed as to render the footings of the pages a difficult matter. The committee, therefore, deemed it proper to order the whole book to be copied in a neat and workman like manner under the direction

and inspection of the Clerk and the assessor with instructions to place the property of each tax payer together so that its value can be carried out in one gross sum, to supply omissions whenever ascertained, to make the firgures plain and set them in proper order under each other so that the addition of the columns may be made with facility and accuracy, and in all respects to make it such a document as should /have been/ be received by the Council. It is but an act of justice to Mr Little the Assessor to say that he evinced and entire willingness and disposition to do whatever he could to facilitate the object had in view by the committee. On enquiry we learn that the work of copying is not yet completed, & it may be proper to extend the time further.

One weeks further Time was granted the assessor to make return of assessment roll.

Mr. Newcomb from a select committee on that subject made

the following report:

The committee appointed to confer with the City Engineer & report as to the practicability of changing the grade of Meridian Street North of North street so as to obviate the objections of the property holders thereon to the present grade, respectfully report, that owing to the sickness of the Engineer he has not been able to attend your committee in their examination of said street, your committee waited upon the engineer and examined a plat of said portion of Meridian street, by which it appears that the present grade on Meridian street at the crossing of St. Clair street is two feet and forty hundredths above the grade for Illinois Street immediately west. Your committee, therefore, believe that the grade of Meridian Street can be lowered one foot & three inches at St Clair Street which would lower the grade thence, North to the same extent. The undersigned, therefore, recommend that the grade be so changed and that the grade descend from Walnut Street to St Clair Street and from Walnut Street South to North Street, and that no change be made in the grade at North Street. All upon the condition that a bond to the acceptance of the City Clerk be filed in his office by the parties interested or some of them within five days, conditioned that the obligors of said bond pay to the contractors for the grading of Meridian Street, the additional expense of making the change in said grade if any. And the committee report the following resolution:



On Motion by Mr Newcomb it was Ordered, That the Civil Engineer give estimate for work done on Meridian street.
