To the Honorable Mayor and Common Council of the City of Indianapolis Gentlemen



I desire to Submit for your consideration the following report to wit. I have visited all the Engine houses during the present week, and I find all the Engines which are used in the department in good order, except the Conquerer. She is out of order now in Consequence of haveing had her Suction broken at one of the late fires I have upun the instruction of your committee on Fire department Sent to Pawtucket Rhode Island for a new piece of Suction, with instructions to have it Sent on as Soon as possible by express. I do not know what the cost will be. I also requested the manufacturer to Send the bill with the Suction for collection I hope you will make Some arrangement to have the bill paid when it comes, so that the engine can be put into Service immediately. I beg again leave from your honorable body to recommend that you cause to be put in each of the Engine houses a good force pump, to be used in cleaning hose, and in this Connection I will Say that on last Wednesday evening in going to all the houses in the City to See if they were well heated, I found that the hose in four houses in very bad condition, they not haveing been cleaned since the fire at the Slaughter house, being Some two weeks Since however the messenger of releif fire Company has Some excuse, he haveing to carry the water and a large amount too about one Square in buckets it is true that the other Companies have wooden pumps I that Some of the Companies do not require their Messengers to do their duty as they Should, hose Should be cleaned within twenty four hours

after a fire. Some of them pay their messengers one hundred and fifty dollars per year that is Sufficient pay to Secure the work well done, and promotly done. I called on the Standing committees as Soon as possible and informed them that their hose must be cleaned. I would here Suggest that if it could be so arranged with the different fire Companies, that the City Contract with Some competent person at a yearly Salary to keep the machinary in good order, if hose are permited to remain So long with out being cleaned, they cannot last half So long as they otherwise would. So you will at once See the absolute necessity of a reform in this particular I would reccommend the purchase of Six hundred feet of hose for No 2 fire Company they have not enough hose now to render them efficient I have been informed that aabout two years ago the Council ordered the the purchase of new hose for all the Companies at that time the number 2 Company were getting a new Engine, and they told Andrew Wallace Esqr than Chief Fire Engineer that they would mather



not get their hose then for the reason that they wanted their new hose to fit their new Engine. So that the hose for them have never been obtained. I would again recommend the immediate Construction of Some large Wells along on Pogues run on the north Side, in order that we may have a good Supply of Water in that locality, this is a time of year when their is a large amount of property in danger, and a time when the run in all probability will be frozen hard and tight. a Small amount of money now expended might be the means of Saving a hundred thousand dollars worth of property in case of fire, before the winter is over. I hope you will take this matter into Serious consideration So that Something may be done as Soon as possible, all of which is respectfully Submited.

Section 4th That the City Treasurer Shall on recieveing Said bonds of the clerk execute his reciept therefore, and Shall on the redemtion of any of Said bonds forthwith Surrender the Same to the clerk to be canceled, and the Clerk shall give a reciept for each bond So Surrendered all of which proceedings Said Treasurer Shall report to the Common Council at its next meeting.






